DIRECTIONS FOR USE

To be used only in the manufacturing of antimicrobial products registered under the PEST CONTROL PRODUCTS ACT or products exempt from registration under Schedule II of the PEST CONTROL PRODUCTS ACT. Manufacturers are responsible for their own registrations.

PRECAUTIONS

WARNING CORROSIVE: Avoid contact with skin and eyes. May cause severe skin and eye irritation or chemical burns to broken skin. Causes eye damage. Wear safety glasses or goggles and rubber gloves when handling this product. Wash after handling. Avoid breathing vapors. Vacate poorly ventilated areas as soon as possible. Do not return until odors have dissipated. Harmful if swallowed.

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL

Mix only with water according to directions. Mixing this product with chemicals (e.g. ammonia, acids, detergents, etc.) or organic matter (e.g. urine, feces, etc.) will release chlorine gas irritating to eyes, lungs and mucous membranes.

FIRST AID:

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.
