DIRECTIONS FOR USE: FOR INDUSTRIAL USE ONLY AS A MICROBIOSTAT PRESERVATIVE INTENDED TO PROTECT POLYMER EMULSIONS, EMULSION PAINT AND COATINGS, MINERAL SLURRIES AND DISPERSIONS, LATICES, ADHESIVES, METALWORKING FLUIDS, JOINT COMPOUNDS AND EIFS FINISH.

Mergal®753 is an effective preservative for use in the above mentioned materials, including industrial and institutional products to control growth of bacteria and fungi. Use rate is 0.006-0.11% wt/wt of Mergal®753 in the finished product (60-1100 grams of Mergal®753 per 1000 kg of finished product). Trials are suggested in order to determine the most effective use level within the label rates of Mergal®753.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN AND PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Corrosive. Causes severe eye damage. May cause allergic skin reactions. Do not get in eyes, on skin or on clothing. Wear goggles or face shield, a long-sleeved shirt, long pants and chemical resistant gloves when handling this product. Avoid breathing dust. Do not take internally. Harmful if swallowed. Avoid contamination of food. Wash thoroughly with soap and water after handling and before eating, drinking or using tobacco. Remove and wash contaminated clothing before reuse.

FIRST AID:

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

IF SWALLOWED: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.

IF INHALED: Move person to fresh air. If person is not breathing call 911 or an ambulance, then give artificial respiration preferably by mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression and convulsion may be needed. Take medicinal carbon. Avoid alcohol.

ENVIRONMENTAL HAZARDS: This product is toxic to fish and wildlife. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries or oceans. Do not contaminate water by cleaning of equipment or disposal of waste.

STORAGE: Protect from frost: If frozen, allow to thaw, stir well before use.

DISPOSAL / DECONTAMINATION:

1. Triple or pressure rinse the empty container thoroughly. Add the rinsings to treatment site.
2. Follow provincial instruction for any required additional cleaning of the container prior to its disposal.
3. Make the empty container unsuitable for further use.
4. Dispose of the container in accordance with provincial requirements.
5. For information on the disposal of unused, unwanted product, contact the provincial regulatory agency or the manufacturer. Contact the manufacturer and the provincial regulatory agency in case of a spill, and for clean-up of spills.
