### **DIRECTIONS FOR USE:**

Greenhouse Use (on Ornamental, tomatoes, peppers and cucumbers). May be used against Two Spotted Spider Mites, Aphids, Greenhouse Whitefly, Sweetpotato whitefly, mealybugs, earwigs.

Outdoor Use (Ornamentals, trees, shrubs, flowers, fruits and vegetables). May be used against Two Spotted Spider Mite, Aphids, Whitefly, Sweetpotato whitefly, mealybugs, earwigs, soft brown scale, rose and pear slugs (sawfly larvae), elm leaf miner.

Shake well before use. Spray thoroughly on both sides of the foliage and stems. The insects must be covered with spray. Safety to all varieties of ornamental plants has not been determined. Test spray on a few of a plant's leaves before using on the whole plant.

Spray once every 2 weeks, or as needed, based on monitoring of pest populations.

**USE PRECAUTIONS:** When treating a plant cultivar for the first time, spot treat a portion of the cultivar, and wait at least 24 hours to see if any phytotoxic symptoms develop, before treating an entire group of plants.

**PRECAUTIONS:** KEEP OUT OF REACH OF CHILDREN. May cause irritation to skin and eyes. Avoid contact with skin or eyes. Wash hands and face after handling of the product.

**FIRST AID:** In case of contact with eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. In case of contact with skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:** Treat patients symptomatically.

**STORAGE:** Shall not be kept with food stuff. Keep out of freezing temperatures.

**DISPOSAL:**

Do not reuse container. Wrap and dispose of empty container with household garbage.
