## **DIRECTIONS FOR USE:**

SPECTRUM® XD3899 Microbiocide Agent is to be used for the control of bacteria, fungi and algae in paper mill whitewater systems and starch slurries. It must be used in conjunction with 1) Sodium Hypochlorite (12.5%) to produce the actual biocide; and 2) the SPECTRUM® XD3899 Microbiocide Agent feeder/delivery system (described below). The mixing is to be done at a ratio of 2.2 litres of Sodium Hypochlorite (12.5%) with 1.0 L of SPECTRUM® XD3899 Microbiocide Agent in the feeder.

SPECTRUM® XD3899 Microbiocide Agent and the oxidant are mixed in a specially designed feeder which produces the biocide on site. The SPECTRUM® XD3899 Microbiocide Agent feeding system controller ensures the production of the dilute biocide solution, checks and controls the production of the biocide continuously, and optimizes the biocide production process. The design of treatment, installation, calibration and operation of the feeding system in all plants should be conducted only by authorized and trained personnel. The biocide produced by the feeder is immediately added to the process waters for which treatment is required. The biocide may be added to any point of uniform mixing. Addition may be continuous or intermittent depending on the severity of the contamination when treatment starts, and on other system operation parameters.

Note: Do not use other feeding modes to mix SPECTRUM® XD3899 Microbiocide Agent and the oxidant, or mix SPECTRUM® XD3899 Microbiocide Agent with other additives so as to avoid decomposition of the biocide. The design of treatment, installation, calibration and initial operation of the feeding system in all plants should be conducted only by authorized and trained personnel. Use of this product for any other purposes or contrary to the instructions below, or without the supervision of authorized trained personnel is prohibited. #### **PULP AND PAPER MILLS**

Used for the prevention of algal, bacterial and fungal slimes, in pulp and paper mill whitewater systems and starch slurries. Badly fouled process systems must be cleaned before initial treatment. Total chlorine residuals can be monitored using a DPD standard chlorine test kit.

Whitewater Systems: Add sufficient biocide produced by the feeder to achieve and maintain a measured concentration of 0.5 -5.0 ppm residual biocide, expressed as total chlorine. SPECTRUM® XD3899 Microbiocide Agent can be used in paper and paperboard components that contact food at a feed of up to 0.93 kg (0.75 liter) of SPECTRUM XD3899 Microbiocide Agent per 1000 kg of dry weight fibre provided that the residual biocide concentration is maintained between 0.5 - 5.0 ppm.

<u>Starch Slurries</u>: Add sufficient biocide produced by the feeder to achieve and maintain a measured residual biocide concentration of up to 10.0 ppm in process waters, expressed as total chlorine.
