For use as a spot or crack and crevice treatment to control Earwigs.

**GENERAL DIRECTIONS:** Hold container approximately 30 cm from surface being sprayed and spray until wet. Thorough applications produce a coating which will vapourize into cracks and crevices for Earwig control. If reinfestation occurs, repeat applications as necessary. Provide adequate ventilation after indoor use. **KEEP PETS AND CHILDREN AWAY FROM SURFACE UNTIL DRY.**

**INDOOR USE:** Thoroughly treat cracks, crevices and spots along and behind baseboards, underneath furniture and equipment, around garbage containers, localized areas of floors and floor coverings and other places where insects hide or are seen.

**OUTDOOR USE:** Spot Treatment: Spray outside surfaces of screens, doors, window frames, foundations, patios, light fixtures and other places where insects may congregate and enter.
