DIRECTIONS FOR USE:

TO CONTROL:	APPLICATION DIRECTIONS:
INDOORS: Ants, cockroaches, crickets, grain insects, spiders, silverfish, centipedes and millipedes.	Gently squeeze or shake container to lightly coat the areas where insects crawl and hide. Apply to cracks and crevices, under/behind appliances, furniture, cupboards, and other places where insects are found. Application rate is 50 g per 10 sq. metres of surface area. Hit the insects directly where possible. Repeat treatment as necessary.
OUTDOORS: Ants, centipedes, wasps, crickets, earwigs, spiders and millipedes.	Lightly coat areas where these insects are found or may hide, including patios, windows, door frames and sills outside of entrance ways, around foundations and along ant trails. Repeat treatment as necessary.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Avoid: breathing dust - contact with eyes. Wash hands after use.

FIRST AID:

If in eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. **If inhaled**, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:

Treat symptomatically.

DISPOSAL:

Do not reuse container. When empty wrap and dispose of with regular household garbage.
