NATURE OF RESTRICTION:

This product is to be used only in a manner authorized; consult provincial pesticide regulatory authorities about use permits that may be required.

RESTRICTED USES:

Only to be used at Ontario Power Generation, Lennox Generating Station.

DIRECTIONS:

Operate the Wedeco Ozone Generator as per the latest versions of the *Lennox GS Operating Instructions* (OI # 7-09), *Lennox GS Sampling Procedure* (SP# 37), and the *Operation and Maintenance Manual Wedeco Effizon Ozone Generating System SMOevo660 Series* to maintain a continuous level of 0.5–0.6 ppm dissolved ozone in the service water intake channel and a residual of 0.1–0.2 ppm dissolved ozone at any point in the service water system. Ozone generator equipment room ventilation must be in service throughout the equipment operation period.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN

Fatal if inhaled. DO NOT inhale/breathe gas. May cause sensitization. Avoid contact with skin, eyes, or clothing. Wear long sleeved shirt, long pants, chemical proof gloves, and eye goggles when handling, and during all clean-up/repair activities. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse.

In the event of a high or very high ozone alarm, do not enter any enclosed locations where alarms have been triggered without respiratory protection until airborne ozone levels are below high alarm levels. Workers who are checking ozone levels using handheld or portable monitors under high or very high ozone alarm conditions must use a NIOSH-approved chemical cartridge respirator specific to ozone or a NIOSH-approved supplied air respirator.

FIRST AID:

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.
