DIRECTIONS FOR USE:

Ortho® Ant B Gon® Max Ant Eliminator is ready to use. Its special formula is non-staining, and has no conspicuous odour. Water, not petroleum distillate is used as the diluent. Within the specified use location, to enhance effectiveness of this product, apply this product directly to the listed pest where possible. Good sanitary practices should be maintained to prevent re-infestation.

How to Apply:

SHAKE WELL BEFORE USING. Adjust spray nozzle to deliver a stream for cracks and crevices or a coarse spray for other areas. Hold sprayer 30 cm (12 inches) from the insect or surface being sprayed. DO NOT APPLY AS A SPACE SPRAY OR BROADCAST APPLICATION. Apply as a crack and crevice or spot treatment only. Spot treatment is localized to surface area not more than 0.2 m². Spots are not to be adjoining and the combined area of spots is not to exceed 10% of the total surface area of a room. Crack and crevice is an application directly into narrow openings on the surface of the structure. It does not include the treatment of exposed surfaces. Narrow openings typically occur at expansion joints, utility entry points and along baseboards and mouldings.
