**DIRECTIONS FOR USE:**

Ortho® Ant B Gon® Max Ant Eliminator is ready to use. Its special formula is non-staining, and has no conspicuous odour. Water, not petroleum distillate is used as the diluent. Within the specified use location, to enhance effectiveness of this product, apply this product directly to the listed pest where possible. Good sanitary practices should be maintained to prevent re-infestation.

**How to Apply:**

**SHAKE WELL BEFORE USING.** Adjust spray nozzle to deliver a stream for cracks and crevices or a coarse spray for other areas. Hold sprayer 30 cm (12 inches) from the insect or surface being sprayed. DO NOT APPLY AS A SPACE SPRAY OR BROADCAST APPLICATION.

Apply as a crack and crevice or spot treatment only. Spot treatment is localized to surface area not more than 0.2 m<sup>2</sup>. Spots are not to be adjoining and the combined area of spots is not to exceed 10% of the total surface area of a room. Crack and crevice is an application directly into narrow openings on the surface of the structure. It does not include the treatment of exposed surfaces. Narrow openings typically occur at expansion joints, utility entry points and along baseboards and mouldings.

**Instructions for inside buildings:** To Kill Ants: Thoroughly treat inside building surfaces, including cracks, crevices in walls, floors and ceilings; along and behind baseboards; around water pipes and tanks; walls behind and floors beneath appliances (e.g., refrigerators and stoves) and furniture (e.g., shelves, drawers, cabinets and storage units); around sinks, drains and pipes; around garbage containers; around interior foundations; localized area around garbage cans; localized areas of floors and floor coverings and points of entry (e.g., around windows and doors). For ants, also spray trails and nests. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

**Outdoors On The Exterior Surfaces Of Buildings:** To Kill Ants: For use outdoors on the exterior surfaces of buildings. Apply to the outside surfaces of foundations, under eaves troughs, around light fixtures, and places where listed pests enter (e.g., screens, doors, window frames). For (pavement) ants, spray onto ant trails, into ant nests and points of entry. Treatment must only be repeated after 14 days if pest problem persists or reoccurs.

**Restrictions:** DO NOT apply to any body of water. DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes. Avoid application of this product when winds are gusty. DO NOT contaminate food/feed. DO NOT apply to surfaces that may come into contact with food/feed. DO NOT apply when people, pets or livestock are present. DO NOT allow people, pets or livestock to enter treated areas until sprays have dried. DO NOT allow spray to drip or allow drift onto non-target surfaces. DO NOT apply to people, pets, livestock or sources of electricity. Unless otherwise stated on this label, DO NOT apply to furniture (excluding bookcases and storage furniture), mattresses, linens, toys or clothing. When applied indoors, DO NOT apply to overhead areas or in confined spaces (for example, attics, crawlspaces). When applied indoors, ventilate treated areas after application by opening windows and doors or using fans, where required, to aid in the circulation of air. When applied outdoors, DO NOT apply in areas where plants are grown for food or feed (e.g., vegetables, fruit, herbs). DO NOT transfer product to another container. DO NOT apply as a space spray or broadcast application.

**STORAGE:**

Rotate nozzle to closed position. Close nozzle on trigger sprayer. Store product in original container in a safe place. Keep from freezing.

**DISPOSAL:**

Do not reuse empty container. Wrap in several layers of newspaper and discard in trash.

**PRECAUTIONS:**

**KEEP OUT OF REACH OF CHILDREN.** Wash thoroughly after handling and before smoking or eating. Remove pets and birds and cover fish aquarium before surface applications. After use and at least one (1) hour drying time, wash all surfaces that may contact food.

**ENVIRONMENTAL PRECAUTIONS;**

Toxic to beneficial insects. Toxic to aquatic organisms. Toxic to birds. This pesticide is highly toxic to bees exposed to direct treatment or to residues remaining on the treated area. Do not apply this product or allow drift when bees are actively visiting the treatment area. Applications should be timed to provide the maximum interval between treatment and the next period of bee activity.

**FIRST AID:**

**If in eyes**, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye.
