DIRECTIONS FOR USE: To be used only in the manufacturing, formulation or repackaging of a pest control product registered under the *Pest Control Products Act*.

PRECAUTIONS: PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Potential skin sensitizer. Harmful if swallowed. Avoid contact with skin, eyes or clothing. Prolonged or frequently repeated skin contact may cause allergic reaction in some individuals. Wash thoroughly after using or before eating, drinking or smoking. Wear clean protective clothing. Formulators and other handlers must wear: Long sleeved shirt and long pants, socks, shoes and chemical resistant gloves made of any waterproof material such as polyethylene or polyvinyl chloride. If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.
