DIRECTIONS FOR USE: To be used only in the manufacture of a product, which is registered under the *Pest Control Products Act*.

PRECAUTIONS: PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. May cause sensitization. May irritate eyes. Avoid contact with skin and eyes and clothing. Avoid breathing mist. Wash thoroughly with soap and water after handling. Wear waterproof gloves, long-sleeved shirt, long pants, socks and shoes, as well as NIOSH-approved particulate filtering facepiece respirator with any N, R or P filter when handling the product and during all clean-up/repair activities. Wash the outside of gloves before removing. Remove contaminated clothing and follow manufacturer's directions for cleaning/maintaining PPE before reuse. If no such instructions are available, use clothing detergent and hot water for cleaning all washable PPE. Keep and wash PPE separately from other laundry. Wash thoroughly with soap and water after handling.

FIRST AID:

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Seek medical attention IMMEDIATELY if irritation occurs and persists or is severe. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: No specific antidote is available. Treat the patient symptomatically.

STORAGE: Store in a secure dry place at -20°C . Do not contaminate water, food or feed during storage. Keep product in original container during storage and keep container lid tightly closed when not in use.

DISPOSAL: Canadian manufacturers should dispose of unwanted active ingredients and containers in accordance with municipal or provincial regulations. For additional details and clean-up of spills, contact the manufacturer or the provincial regulatory agency.
