**GENERAL INFORMATION:**

DEER GUARD® is a ready to use deer repellent that discourages deer from feeding on trees, shrubs, ornamentals, conifers, and non-bearing deciduous trees. Use only at temperatures between 5°C and 32°C (40°F and 90°F). Do not use on food or feed crops. DEER GUARD® has been tested on many species of plants and trees and is not believed to be phytotoxic. Test a small portion of a plant species before treating entire plant. Children and pets may enter treated area after spray has dried. Do not apply or drift onto stone, concrete or siding as staining may occur. **Keep from freezing.**

**DIRECTIONS FOR USE:** Shake well before using. Apply product directly to dry plants only. Hold spray tip 30 to 60 cm (1 to 2 ft) from plants and spray leaves, needles, buds and branches subject to browsing by deer. Thoroughly wet surfaces but not to run-off. For best results, apply to bare branches in fall and to unprotected foliage in spring. Repeat as needed. **Clean application equipment immediately after use before spray dries.**

**PRECAUTIONS****KEEP OUT OF REACH OF CHILDREN**

Harmful if absorbed through skin. Avoid contact with skin, eyes, or clothing. May cause skin reactions. Discontinue use if any skin reactions occur. Wear chemical-resistant gloves when handling DEER GUARD® or contaminated equipment. Wash thoroughly with soap and water after handling and before eating or smoking. Do not reenter treated area until the spray has dried.

**FIRST AID:**

**IF ON SKIN OR CLOTHING,** take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. **IF IN EYES:** Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.
