FIRST AID

If in eyes: Hold eye open and rin se slowly and gently with water for 15-20 minutes. Remove contact lenses, if prese nt, after the first 5 minutes, then continue rinsing eye. Ca II a poison control centre or doctor for treatment advice.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If swallowed: Call a poison control centre or doctor immediately for treatment advice.

STORAGE

Aquarian C422 solutions are corrosive to many commonly used materials of construction such as steel, galvanised iron, aluminium, tin and zinc. These solutions can be stored and handled in baked phenolic lined steel, stainless steel or reinforced epoxy equipment. This product freezes at about -6.5°C (43°F). Therefore, unless the storage tank is inside or underground, heating and insulation may be required. If heating is needed, exposure to high temperatures should be avoided. F or short storage (1 mo nth) temperatures up to 38 °C (100°F) can be tolerated; however, the preferred maximu m storage temperature is approximately 27°C (80°F). Keep away from fire and open flames. A stainless steel centrifugal pump is sugge sted for transfer service. Spiral wound stainless steel with TE FLON is suitable for ga skets and packing. To prevent contamination store this product away from food or feed.

SPILLAGE

Absorb onto sand, ea rth or inert mineral. Sweep u p and remove the spillage to a polythethylene-lined container for subsequent correct disposal. Clean the area with detergent and water.

This pest control product is to be used only in accordance with the directions on the label. DIRECTIONS FOR USE

AIR WASHERS AND INDUSTRIAL SCRUBBING SYSTEMS, RECIRCULATING COOLING AND PROCESS WATER SYSTEMS

This product may be used only in industrial air washer systems which have mist-eliminating components. Aquarian C422 should be added at the application rates described below, to a water treatment syste m at a convenient point of uniform mixing such as the basin area . Addition may be made intermittently (SLUG DOSE) or continuously. Badly fouled systems can be shock treated with Aquarian C422. Un der these conditions, blowdown should be discontinued for up to 24 hours. DO NOT open pour more than 20L of concentrate per day. Use an automatic addition system if using more than 20L of concentrate per day. DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes. DO NOT discharge efflue nt containing this product into sew er systems, lakes, streams, ponds estuaries, oceans or other waters.

Aquarian C422 can be used in industrial process water systems that contain ultra filtration units and non-medical rever se osmosis membrane s (where approved for compatibility by the membrane manufacturer) and associated distribution systems.

INTERMITTENT (SLUG DOSE) METHOD

Initial Dose: When the system is noticeably fouled, add 333 mL - 133 3 mL of Aquarian C422 per 1,000 litres of water in the system. Repeat until control is achieved.

Subsequent Dose: When microbial control is evident, add 100 mL - 333 mL of Aquarian C422 per 1,000 litres of water in the syst em weekly, or as needed to maintain control. Badly-fouled systems must be cleaned before treatment begins.

CONTINUOUS FEED SYSTEM

Initial Dose: When the system is noticeably fouled, apply 333 mL - 1333 mL of Aquarian C422 per 1,000 litres of water in the system.

Subsequent Dose: Maintain these treatments by starting a continuous feed of 50 mL - 333 mL of Aquarian C422 per 1,000 litres of water in the system per day. Badly-fouled systems must be cleaned before treatment begins.

PASTEURIZER COOLING WATER SYSTEM

Avoid contamination of food in the application of product. Aquarian C422 should be used in the same use rates and use pattern as listed above. Aquarian C422 Should be added to the closed recirculating system at a convenient point such as a basin area, sump area, other reservoir or collection area from which the treated water will be circulating uniformly throughout the cooling system.

SERVICE WATER AND AUXILIARY SYSTEMS

Aquarian C422 should be used in the same application rates, and in the same manner as for air washers and recirculating cooling waters. It should be added to the system at a point that will allow for uniform mixing throughout the system.

HEAT TRANSFER SYSTEMS

(Evaporative Condensers, Hydrostatic Sterilizers and Retorts, and Pasteurizers and Warmers)

Aquarian C422 should be used at the same application rates, and in the same manner as described in the Air Wa shers and Recirculating Cooling Tower section above. It should be added to the system at a point of uniform mixing such as a basin are a, sump area or other reservoir collecting area from which the treated water will be circulated uniformly throughout the system.

INDUSTRIAL WASTEWATER SYSTEMS (Wastewater Systems, Wastewater Sludge and Wastewater Holding Tanks)

Aquarian C422 should be added to a wastewater system or sludge at a convenient point of uniform mixing such as the digester. Add 1500 mL to 7500 mL of Aquarian C422 per 1000 litres of wastewater or sludge.
