PRECAUTIONS: PREVENT ACCESS BY UNAUTHORIZED PERSONNEL

Avoid breathing vapors or spray mist. May c ause minimal eye irritation. Avoid contact with skin, eyes or clothing. If in eyes - Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.
