#### **DIRECTIONS FOR USE:**

- SHAKE WELL BEFORE USING.
- Hold can upright at least 120 cm from all objects and aim nozzle away from person. Press button firmly to spray.
- To enhance effectiveness of this product, apply directly to the listed pests where possible. **DO NOT** exceed 3.8 seconds per m<sup>2</sup>. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

#### First Aid:

**If swallowed:** Call a poison control centre or doctor immediately for treatment advice. DO NOT induce vomiting unless told to do so by a poison control centre or doctor. DO NOT give any liquid to the person. DO NOT give anything by mouth to an unconscious person. **If inhaled:** Move person to fresh air. #### **FOR USE ON INDOOR ORNAMENTAL HOUSEPLANTS**

**To kill** Two spotted spider mites **on the following houseplants:** African violet, Aralia, Christmas cherry, Chrysanthemums, Cineraria, Dieffenbachia, Fuchsia, Gloxinia, Ivy, Neathe bella palm. **DO NOT** apply to houseplants grown for food or feed (e.g., herbs). **DO NOT** use on greenhouse plants. When listed pests **first appear**, spray to thoroughly cover all foliage, including upper and lower leaf surfaces until damp. **DO NOT** wet plants to the point of runoff or drip. **When spraying, hold can 30-45 cm from plants to avoid wetting the foliage.** **DO NOT** exceed 3.8 seconds per m<sup>2</sup>. Treatment must only be repeated after 7 days if pest problem persists or reoccurs. Use with caution on new growth and on tender young plants and foliage. Test on one or two leaves to determine safety.
