PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Harmful if inhaled. Avoid breathing vapour or spray mist. May irritate eyes. Avoid contact with eyes. Potential skin sensitizer. Provide adequate ventilation. Workers must wear a long-sleeved shirt, long pants, chemical resistant gloves and goggles or a face shield during mixing, loading, cleanup and repair. Follow manufacturer's instructions for cleaning/maintaining personal protective equipment. If no such instructions exist for washables, use detergent and hot water. Keep and wash personal protective equipment separately from other laundry.

DIRECTIONS FOR USE:

For use as a preservative in manufacturing paints, coatings, plastics and adhesives. DO NOT use for plastic for toys.

For the following applications except Fungitrol 940G Fungicide is to be added during mixing of the raw materials for ease of incorporation into the finished product.

Exterior Paint Dry Film: 0.25 – 0.5% by weight (1000-2000 ppm a.i.)

Plastics (to protect against mildew and fungal growth on products exposed to humid conditions that are not subject to constant wetting such as rain (e.g. vinyl siding) or running water (e.g. PVC pipes)): 0.06 – 0.25% by weight (250 – 1000 ppm a.i.)

Adhesives: 0.05 – 0.125% by weight (200 – 500 ppm a.i.)

The optimum amount of Fungitrol 940G Fungicide that is required for adequate preservation is best determined by actual tests with the specific material, within the above registered range of rates.

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

DO NOT discharge effluent containing this product into sewer systems, lakes, streams, ponds, estuaries, oceans or other waters.

DO NOT use for plastic for toys.

DO NOT use for textile for apparel.

DO NOT use on any fabric where prolonged skin contact may occur. Treated textiles preserved with iodocarb are not to be used in residential settings where bystanders, including children, may potentially contact treated textiles. This includes around homes, schools, parks, playgrounds, playing fields, public buildings or any other areas where the general public, including children, could be exposed.

FIRST AID:

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

This product is toxic to aquatic organisms.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

STORAGE:

Store in a dry place. Do not contaminate water, food or feed by storage or disposal.

Disposal:
