**PRECAUTION**: KEEP OUT OF REACH OF CHILDREN. DO NOT get in eyes, on skin, or on clothing. Harmful if swallowed, inhaled, or absorbed through the skin. Causes eye, skin and respiratory irritation. Persons applying the diluted spray solution must wear a long-sleeved shirt and long pants, shoes, socks, waterproof gloves, and protective eyewear.

Do not apply in a way that this product will contact workers or other persons, either directly or through drift.

Restrict indoor application of the product in commercial facilities to vacant areas only.

Do not enter or allow re-entry into treated areas until the spray is dried and treated areas are thoroughly ventilated.

Handling and loading of the product as well as the clean-up and maintenance activities should be performed in a well-ventilated area.

Apply only when the potential for drift to areas of human habitation or areas of human activity such as houses, cottages, school, and recreational areas is minimal. Take into consideration wind speed, wind direction, temperature inversions, application equipment, and sprayer settings.

### **TOXICOLOGICAL INFORMATION**: Treat symptomatically.

### **FIRST-AID:**

**If swallowed:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

**If inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

**If in eyes:** Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration number with you when seeking medical attention.

DIRECTIONS FOR USE: MTDX-CR can be used in and around buildings to kill accessible, exposed German cockroach nymphs and adults on contact. German cockroaches must be saturated with the spray solution.

**Dilution:** Mix 10 grams of product into 1 litre of warm water resulting in a 1.0% MTDX-CR use solution. Use diluted solution within 24 hours after mixing to avoid product settling in application equipment

**Application**: Test a small inconspicuous area of the surface to be treated for colour fastness, staining and corrosion before full application. Apply this product as a surface spray. Food contact surfaces and equipment must be covered during treatment or cleaned with an effective detergent and rinsed with potable water before reuse. This product provides contact kill with no residual activity. German Cockroaches must be contacted directly with the liquid and become saturated.

**Application Sites:** Thoroughly spray areas where these insects are usually found with special attention to cracks and crevices, niches, dark corners, drains and other harbourage sites.

#### STORAGE & DISPOSAL

**Pesticide Storage:** Store in a cool, well-ventilated area in original container. Keep container tightly closed. To prevent contamination, store this product away from food or feed.

**Disposal:** Non-refillable container. Do not reuse or refill this container.

Triple- or pressure-rinse the empty container. Add the rinsings to the spray mixture in the tank.

Follow provincial instructions for any required cleaning of the container prior to its disposal.

Make the empty container unsuitable for further use.

Dispose of the container in accordance with Provincial requirements.

For information on disposal of unused, unwanted product, contact manufacturer and the provincial regulatory agency. Contact the manufacturer and the provincial regulatory agency in case of a spill, and for clean-up of spills.
