#### DIRECTIONS FOR USE

**SHAKE CAN WELL BEFORE USING.** Remove protective cap and insert "applicator wand" into spray nozzle before using. Test a small inconspicuous area for color fastness & staining before full application. Hold container approximately 30 cm from surface being sprayed and lightly spray. Cover fishbowls when spraying. Within the specified use location, to enhance effectiveness of this product, apply this product directly to the listed pest where possible. Good sanitary practices should be maintained to prevent re-infestation. **DO NOT** spray product in areas where it can be mopped away.

FOR INDOOR USE IN BUILDINGS AND FOR OUTDOOR USE ON THE EXTERIOR SURFACES OF BUILDINGS, GARBAGE CANS AND ON PORCHES, PATIOS AND DECKS

#### HOW TO APPLY

**DO NOT** APPLY AS A SPACE SPRAY, PERIMETER OR BROADCAST TREATMENT. Apply as an indoor crack and crevice or indoor or outdoor spot treatment only. **CRACK AND CREVICE** is an application directly into narrow openings on the surface of the structure. It does not include the treatment of exposed surfaces. Narrow openings typically occur at expansion joints, utility entry points and along baseboards and mouldings. **SPOT APPLICATION** is localized to a surface area not more than 0.2 m<sup>2</sup>. Spots are not to be adjoining and the combined area of spots is not to exceed 10% of the total surface area of a room (indoors) or total surface area treated (outdoors).

#### USE LIMITATIONS FOR ALL USES

**DO NOT** apply to surfaces that may come into contact with food/feed. Cover or remove all food/feed. Cover all food/feed processing surfaces, equipment and utensils or thoroughly wash following treatment. Any food/feed accidentally contaminated with spray solution must be discarded. **DO NOT** apply when people, pets or livestock are present. **DO NOT** allow people, pets or livestock to enter treated areas until sprays have dried. **DO NOT** allow spray to drip or allow drift onto non-target surfaces. **DO NOT** apply to people, pets, livestock or sources of electricity. **DO NOT** apply to mattresses, linens, toys, or clothing. **DO NOT** apply to overhead areas or in confined spaces (for example, indoors in attics, crawlspaces, small storage rooms, closets and outdoors to eaves, soffits). When applied indoors: Ventilate treated areas after application by opening windows and doors or using fans where required to aid in the circulation of air. When applied outdoors: **DO NOT** apply in areas where plants are grown for food or feed (e.g., vegetables, fruit, herbs). Avoid spraying vegetation and non-target structural surfaces. Hose off any plants or non-target structural surfaces that are contacted with spray with water. **DO NOT** apply to any body of water. **DO NOT** contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes. Avoid application of this product when winds are gusty. When applied outdoors to the exterior surfaces of buildings and on listed structures: **DO NOT** treat soil, turf or other plants adjacent to the treatment site.

#### FOR INDOOR USE IN BUILDINGS:

TO KILL ANTS, CARPET BEETLES, COCKROACHES, CRICKETS, EARWIGS, MILLIPEDES, SOW BUGS, SPIDERS AND SILVERFISH: Thoroughly treat indoor building surfaces in hard to reach places areas including, cracks, crevices in walls, floors and ceilings; along and behind baseboards; around water pipes and tanks; walls behind and floors beneath appliances (e.g., refrigerators and stoves) and furniture (e.g., drawers, cabinets and storage units); around sinks, drains and pipes; around interior foundations; garbage cans; localized areas of floors and floor

coverings; and points of entry (e.g. around windows and doors). **DO NOT** exceed 7 seconds per m<sup>2</sup>. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

**TO KILL DOG AND CAT FLEAS AND AMERICAN DOG AND BROWN DOG TICKS: DO NOT SPRAY PETS WITH THIS PRODUCT. DO NOT** apply to pet bedding, furniture, mattresses, linens, toys or clothing. Only treat pets with products specifically registered for use on that type of pet. Apply to indoor building surfaces, including cracks and crevices in walls and floors, along and behind baseboards, window and door frames, and localized areas of floor and floor coverings. For effective flea and tick control indoors, clean any area used by the pet. Cleaning the areas includes vacuuming floors, carpets, furniture, etc. (discard vacuum bag after use) and washing the pet's bedding, living quarters, and surrounding area. **DO NOT** exceed 7 seconds per m<sup>2</sup>. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

#### OUTDOOR USE

**TO KILL SPIDERS, SOW BUGS, EARWIGS, COCKROACHES, CRICKETS, ANTS, DOG AND CAT FLEAS, AMERICAN DOG AND BROWN DOG TICKS, MILLIPEDES, HOUSE FLIES AND CLUSTER FLIES:** For use as a spot treatment only on the exterior surfaces of buildings, garbage cans and on patios, porches and decks.. Apply to the outside surfaces of foundations, under eaves, around light fixtures, and places where listed pests enter (e.g., screens, doors, window frames). This product may also be applied to garbage cans and localized areas of patios, porches and decks. House flies and cluster flies will be killed when they land and crawl on the treated surfaces. **DO NOT** exceed 7 seconds per m<sup>2</sup>. Treatment must only be repeated after 14 days if pest problem persists or reoccurs.

#### OUTDOOR USE ON ANT HILLS:

**TO CONTROL ANTS AROUND BUILDINGS INCLUDING DRIVEWAYS, PATIOS, SIDEWALKS, OR INTERLOCKING BRICK.** Gently insert the extension tube as far as possible into cracks and crevices in driveways, patios, sidewalks, or interlocking brick where ants hide. Depress nozzle and allow foam to fill the area. Stop spraying when the foam comes back out the crack or crevice. For best results, treat all cracks and crevices in the area where ants are found. **DO NOT** exceed 7 seconds per m<sup>2</sup>. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

**PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN.** Harmful if swallowed, inhaled or absorbed through skin. Avoid contact with eyes, skin, or clothing. May cause skin and/or eye irritation. Contents under pressure. **DO NOT** place in hot water or near radiators, stove or other sources of heat, or store at temperatures over 50°C.

**ENVIRONMENTAL PRECAUTIONS:** Toxic to aquatic organisms. Toxic to bees. Avoid application around blooming plants. If applications must be made during the blooming period, restrict applications to evening when most bees are not foraging. Toxic to beneficial arthropods (which may include predatory and parasitic insects, spiders, and mites). Minimize exposure to non-target areas.

**FIRST AID: IF ON SKIN OR CLOTHING,** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. **IF IN EYES,** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye.
