DIRECTIONS FOR USE:

FOR USE IN MANUFACTURING, FORMULATING OR PACKAGING. TO BE USED ONLY IN THE MANUFACTURE OF PRODUCT REGISTERED UNDER THE *PEST CONTROL PRODUCTS ACT*, THE *FERTILIZER ACT* OR FOR REGISTERED PRODUCTS FOR EXPORT.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN AND/OR UNAUTHORIZED PERSONNEL. Corrosive, causes irreversible eye damage. Avoid breathing vapours or spray mist. Do not get in eyes, or skin, or clothing. Wear goggles or face shield and rubber gloves when handling. If eye exposure occurs, get immediate medical attention. Avoid inhalation of spray mists. Harmful or fatal if swallowed. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse. Do not apply directly to water. Do not contaminate water by cleaning of equipment or disposal of wastes. Do not contaminate domestic or irrigation waters.

FIRST AID:

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:

High concentrations of MCPA may cause severe irritation to the eyes. Symptoms of overexposure to MCPA could include slurred speech, twitching, jerking and spasms, drooling, low-blood pressure and unconsciousness. Treat symptomatically.

STORAGE:

Keep in original container during storage. Store product in cool, dry, well ventilated place away from seed, feed, fertilizers, or other pesticides. Keep away from fire or open flame, or other source of heat.

DISPOSAL:

Canadian formulators using this product should dispose of unwanted active ingredient and containers in accordance with municipal or provincial regulations.
