**DIRECTIONS FOR USE**

Remove animals for a minimum of 1 hour when spraying room. Following treatment, ventilate all rooms, do not access for a minimum of 15 minutes and do not re-enter before ventilation is complete. Do not use tetramethrin in food handling, storage or preparation areas while food is present.

**Residential areas** are defined as any use site where the general public, including children, could be exposed during or after application. For structural uses, in residential sites, this includes homes, schools, restaurants, public buildings or any other areas where the general public including children may potentially be exposed. Non-residential areas include, but are not limited to: industrial/commercial indoor sites (for example, laboratories, warehouses, food granaries); modes of transport in areas where passengers are not present (for example, buses, railcars, trailers); and animal housing (for example, livestock housing and poultry, pet kennels).

**Restrictions:**

- DO NOT apply to any body of water.
- DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.
- Avoid application of this product when winds are gusty.
- DO NOT contaminate food/feed. DO NOT apply to surfaces that may come into contact with food/feed.
- DO NOT use in food handling, storage, or preparation areas while food is present.
- DO NOT apply when people, pets or livestock are present.
- DO NOT allow people, pets or livestock to enter treated areas until sprays have dried.
- DO NOT allow spray to drip or allow drift onto non-target surfaces.
- DO NOT apply to people, pets, livestock or sources of electricity
- DO NOT apply to furniture, mattresses, linens, toys or clothing.
- When applied indoors, DO NOT apply to overhead areas or in confined spaces (for example, attics, and crawlspaces).
- When applied indoors, ventilate treated areas after application by opening windows and doors or using fans where required to aid in the circulation of air. Following treatment, do not access areas for a minimum of 15 minutes and do not re-enter before ventilation is complete.
- DO NOT apply as a space spray or broadcast application.

**How to Apply:**

**USE ONLY AS A SPOT OR CRACK AND CREVICE APPLICATION.**

**FOR SPOT APPLICATION:** Spot treatment is localized to a surface area not more than 0.2 m<sup>2</sup>. Spots are not to be adjoining and the combined area of spots is not to exceed 10% of the total surface area of a room.

**FOR CRACK AND CREVICE APPLICATION:** Crack and crevice is an application directly into narrow openings on the surface of the structure. It does not include the treatment of exposed surfaces. Narrow openings typically occur at expansion joints, utility entry points and along baseboards and mouldings.

**Application Instructions:** [SHAKE (WELL) BEFORE USE. HOLD CONTAINER UPRIGHT.]

[APPLY IN SHORT BURSTS.] Within the specified use location, to enhance effectiveness of this product, apply this product directly to the listed pest where possible.

**INSTRUCTION FOR INSIDE BUILDINGS:**

**To Kill Ants, Carpet Beetles, Cockroaches, Crickets, Earwigs, Silverfish, Sowbugs and Spiders:**

Spray small amounts of this product as a crack and crevice or spot application to indoor building surfaces, including dark corners of rooms; cracks and crevices in walls, floors and ceilings; along baseboards and door and window frames; around sinks; to walls behind and floors beneath appliances (e.g., stoves, refrigerators) and furniture (e.g., cabinets); around garbage cans, plumbing and other utility installations; around points of entry (e.g., windows, doors). For ants, also spray trails and nests. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

**To Kill Brown Dog Ticks and Fleas: DO NOT SPRAY PETS WITH THIS PRODUCT.** Only treat pets with

products specifically registered for use on that type of pet. For effective flea and tick control, treatment of the pet should be combined with the cleanup and sanitation of any area used by the pet. Vacuum floors, carpets, furniture, etc. (discard vacuum bag after use) and wash the pet's bedding, living quarters, and surrounding area. Apply to indoor building surfaces, including cracks and crevices in walls and floors, along and behind baseboards, window and door frames, and localized areas of floor and floor coverings. Pet bedding may be entirely treated with this product or replaced with clean, fresh bedding after other listed areas are treated. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

**FOR OUTDOOR USE ON THE EXTERIOR SURFACES OF BUILDINGS AND ON PORCHES, PATIOS AND**

**DECKS: House Flies and Mosquitoes:** For use as an aid in reducing nuisance from house flies and mosquitoes. For use as a spot application to localized areas on the exterior surfaces of buildings (including garages) and localized areas on porches, patios and decks. Apply to the outside surfaces of foundations, under eaves troughs, around light fixtures, and places where insects enter (e.g., screens, doors, window frames). House Flies and mosquitoes coming to rest on treated surfaces will be killed. Treatment must only be repeated after 14 days if pest problem persists or reoccurs.

**PRECAUTIONS:** KEEP OUT OF REACH OF CHILDREN AND PETS. Avoid contact with eyes, skin and clothing. Harmful if swallowed. May cause eye or skin irritation. Do not inhale vapors. Wash well after handling and before eating, drinking and smoking. Wash contaminated clothing with soap and hot water before reuse. Do not wear contaminated shoes.

**FIRST AID: If inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. **If swallowed:** Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person. **If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. **If in eyes:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically. This product contains petroleum distillates. Vomiting may cause aspiration pneumonia.

ENVIRONMENTAL PRECAUTIONS: This product is toxic to aquatic organisms. Toxic to birds. Toxic to beneficial insects. Toxic to bees. Do not spray bees.

DISPOSAL: Do not reuse empty container. Wrap empty container and discard in household garbage.

STORAGE: Store only in original container in a cool, dry place inaccessible to children, pets and domestic animals. Store above 0°C – Do Not Freeze.
