DIRECTIONS FOR USE

Restrictions: DO NOT apply to any body of water. DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes. Avoid application of this product when winds are gusty. DO NOT contaminate food/feed. DO NOT apply to surfaces that may come into contact with food/feed. DO NOT use in food handling, storage, or preparation areas while food is present. DO NOT apply when people or pets [or livestock] are present. DO NOT allow people or pets [or livestock] to enter treated areas until sprays have dried. DO NOT allow spray to drip or allow drift onto non-target surfaces. DO NOT apply to people, pets, livestock, or sources of electricity. DO NOT apply to furniture, mattresses, linens, toys or clothing. DO NOT apply to overhead areas or in confined spaces (for example, attics, crawlspaces, small storage rooms, closets). Ventilate treated areas after application by opening windows and doors, or using fans where required to aid in the circulation of air. DO NOT apply as a space spray or broadcast application. When used outdoors on exterior surfaces of buildings, porches, patios and decks, DO NOT treat soil, turf or other plants adjacent to the structure.

How to Apply: USE ONLY AS A SPOT OR CRACK AND CREVICE APPLICATION. For spot and perimeter application: Spot treatment is localized to a surface area not more than 0.2 m². Spots are not to be adjoining and the combined area of spots is not to exceed 10% of the total surface area of a room. For crack and crevice application: Crack and crevice is an application directly into narrow openings on the surface of the structure. It does not include the treatment of exposed surfaces. Narrow openings typically occur at expansion joints, utility entry points and along baseboards and mouldings.

Application Instructions:

SHAKE BEFORE USE. HOLD CONTAINER UPRIGHT. APPLY IN SHORT BURSTS. ALWAYS USE THE ENCLOSED RED EXTENSION TUBE TO DIRECT THE APPLICATION. Within the specified use location, to enhance effectiveness of this product, apply this product directly to the listed pest where possible.

For Indoor Use:

To Kill Ants, Carpet Beetles, Cockroaches, Crickets, Earwigs, Silverfish, Sowbugs and Spiders: Spray as a spot application to indoor building surfaces, including dark corners of rooms; cracks and crevices in walls, floors and ceilings; along baseboards and door and window frames; around sinks; to walls behind and floors beneath appliances (e.g., stoves, refrigerators) and furniture (e.g., cabinets); around garbage cans, plumbing and other utility installations; around points of entry (e.g., windows, doors). Apply as a crack and crevice or void application using the pin-stream setting to apply small amounts of this product directly into the cracks and crevices or voids found between different elements of construction, between equipment and floors, openings leading to voids and hollow spaces in walls and furniture legs. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

To Kill Brown Dog Ticks and Fleas: DO NOT SPRAY PETS WITH THIS PRODUCT. Only treat pets with products specifically registered for use on that type of pet. For effective flea and tick control, treatment of the pet should be combined with the cleanup and sanitation of any area used by the pet. Vacuum floors, carpets, furniture, etc. (discard vacuum bag after use) and wash the pet's bedding, living quarters, and surrounding area. Apply to indoor building surfaces, including cracks and crevices in walls and floors, along and behind baseboards, window and door frames, and localized areas of floor and floor coverings. Pet bedding may be entirely treated with this product or replaced with clean, fresh bedding after other listed areas are treated. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

For Outdoor Use on the Exterior Surfaces of Buildings and on porches, patios and decks:

To Kill House Flies and Mosquitoes: For use as a spot application to localized areas on the exterior surfaces of buildings (including garages) and localized areas on porches, patios and decks. Apply to the outside surfaces of foundations, under eaves troughs, around light fixtures, and places where insects enter (e.g., screens, doors, window frames). House Flies and mosquitoes coming to rest on treated surfaces will be killed. Treatment must only be repeated after 14 days if pest problem persists or reoccurs.

KEEP OUT OF REACH OF CHILDREN AND PETS. Avoid contact with eyes, skin and clothing. Harmful if swallowed. May cause eye or skin irritation. Do not inhale vapors. Wash well after handling and before eating, drinking and smoking. Wash contaminated clothing with soap and hot water before reuse. Do not wear contaminated shoes. Remove animals for a minimum of 1 hour when spraying room. Following treatment, ventilate all rooms, do not access for a minimum of 15 minutes and do not re-enter before ventilation is complete. Avoid contact with treated surfaces until dry. Residential areas are defined as any use site where the general public, including children, could be exposed during or after application. For structural uses, in residential sites, this includes homes, schools, restaurants, public buildings or any other areas where the general public including children may potentially be exposed.

FIRST AID

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.
