DIRECTIONS FOR USE:

For use to control house mice (*Mus musculus*) indoors and outdoors within 15 metres of buildings accessible to children, pets and non-target animals. DO NOT place bait station in areas where there is a possibility of contaminating food or surfaces that come in direct contact with food, or in areas where there is a possibility of contaminating sources of drinking water.

SELECTION OF TREATMENT AREAS: Determine areas where mice will most likely find and consume the bait. Generally, these areas are along walls, by gnawed openings, in or beside burrows, in corners and concealed places, between floors and walls, or in locations where rodents or their signs have been observed. Remove as much food as possible.

APPLICATION DIRECTIONS:

Use 1 bait station per placement. Place the bait station at highest point of activity beside burrows, along a wall or in corners where mice or their signs have been seen. If additional units are to be used, place bait stations at 2 to 4 metre intervals. Maintain an uninterrupted supply of fresh bait for at least 7 days. Continue baiting until signs of mouse activity cease.

Collect and dispose of bait stations with unconsumed bait and dead exposed rodents according to local requirements and/or the disposal instructions found on this label. To prevent reinfestation, eliminate food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish as needed.

PRECAUTIONS: KEEP AWAY FROM CHILDREN, PETS AND LIVESTOCK. Bait station contents may be harmful or fatal if swallowed or absorbed through the skin. Rubber gloves must be worn when collecting and disposing of emptied bait stations, unconsumed bait and dead rodents. Avoid contact with eyes, skin or clothing. Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Wash skin thoroughly with soap and water after handling. Wash contaminated clothing, separately from other laundry, with soap and water before reuse. KEEP AWAY FROM FEED AND FOODSTUFFS.

FIRST AID: If in eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. If swallowed, call

a poison control centre or doctor immediately for treatment advice. Do not give any liquid to the person. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. For all cases of human ingestion, immediately notify a physician or Poison Control Centre. If a pet or livestock poisoning is suspected, immediately contact a veterinarian. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Tomcat® Mouse Killer Bait Station is not an anticoagulant type rodenticide. If ingested, limit absorption by either emesis or gastric lavage. Sublethal symptoms, if present, would be the result of cerebral edema and should be treated accordingly through the administration of an osmotic diuretic and corticosteroid.

ENVIRONMENTAL HAZARDS: This product is toxic to fish, birds, and wildlife. Keep out of lakes, rivers, streams or ponds.

DISPOSAL: Do not reuse empty container. Wrap unwanted or damaged bait station and discard in household garbage. DO NOT use damaged bait stations.

CARCASS DISPOSAL: To protect pets and non-target wildlife, carefully dispose of animals killed by this bait. Wrap poisoned carcasses securely with paper. Dispose of them by: placing in a closed container in the garbage OR burying deep enough to prevent scavengers from reaching them.

STORAGE: Store in cool, dry place away from other chemicals and food or feed. Store product not in use, in original container, in a secure location inaccessible to children and non-target animals.
