DIRECTIONS FOR USE:

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes. DO NOT apply this product in a way that will result in direct contact with adults, children or pets.

For optimum result ensure pump and filter are in proper working order, start with fresh water. Balance water (test and adjust pH to 7.2, total alkalinity 120 ppm, water hardness 200 ppm). When used as directed, C-SPA Mineral Treatment provides extended water protection by eliminating algae and increasing bacterial control capacity of primary sanitizer.

Chlorinate spa water (3-5 ppm). Once water is in balance add 60 g (2 oz.) of C-SPA Mineral Treatment per 4500 L (1000 gal.) of spa water by sprinkling on water surface during filter cycle which result in a minimum concentration of 0.4 ppm copper. Next day remove filter and clean.

DO NOT apply this product in a way that will result in direct contact with adults, children or pets.

WEEKLY: Elevated water temperatures require more frequent oxidation, water testing pH/alkalinity adjustments. Test and adjust all levels. Chlorinate spa (3-5 ppm) then add (30 g (1 oz.) of C-SPA Mineral Treatment per 4500 L (1000 gal) of spa water by sprinkling on water surface during filter cycle to yield a concentration of 0.2ppm of copper. Next day remove filter and clean. Maintain sanitation levels at all times and super-chlorinate weekly. An ideal chlorine reading of 1.5ppm is recommended. If using a chlorinator, fill and place on lowest setting. Check and adjust pH to 7.2. In periods of high

temperatures or heavy traffic, it is recommended that chlorine be used daily. Test the copper level every week and add C-SPA Mineral Treatment proportionally to maintain 0.4ppm of copper. Do not allow copper level to drop below 0.4 ppm. .

For proper sanitation, spa must be completely drained periodically. The number of days between **complete spa drainage** is equal to the volume of spa water in litres, divided by 10 times the maximum number of daily spa users. Refill spa with water and repeat **Directions for Use**.

Maximum spa water usage temperature is 40°C. Duration in spa water at 40°C should not exceed 15 minutes.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Do not get C-SPA Mineral Treatment in eyes or on skin. Wear safety glasses. Wash hands thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet. Remove contaminated clothing and wash clothing. Harmful if swallowed. Do not mix with other chemicals. DO NOT allow adults, children or pets to enter the treated area until dusts have settled.

FIRST AID:
