**DIRECTION FOR USE:**

To be used only in the manufacture of a pesticide registered under the PEST CONTROL PRODUCTS ACT.

Formulators are responsible for obtaining their own registrations for their formulated pest control products. Post a copy of this label in the work area.

**PRECAUTIONS: PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.**

Strictly observe all precautions for handling and using pesticides. Avoid contact with skin, eyes and clothing. Do not contaminate food, feed or water supplies. Workers using this product in an open system must wear protective clothing: safety boots, coveralls, impervious gloves, safety glasses/faceshield and cartridge-type respirator.

**STORAGE:**

Store in the original container in a well ventilated, cool, dry, secure area. Do not contaminate water, food, feed or seed during shipping nor by storage or disposal. Keep container tightly closed.

**FIRST AID:**

**IF SWALLOWED:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**IF IN EYES:** Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

**IF ON SKIN OR CLOTHING:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

**IF INHALED:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take the container label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:** There is no specific antidote for this product. Treat symptomatically.

**ENVIRONMENTAL PRECAUTIONS:**

**TOXIC** to aquatic organisms.
