**DIRECTIONS:** Shake can well before using. Hold can upright while spraying. To kill bed bugs, spray directly on mattress, particularly around seams and tufts. Take beds apart, spray all joints. Repeat as required. Bed bugs must be hit directly to be killed.

**PRECAUTIONS:** KEEP OUT OF REACH OF CHILDREN. Contents under pressure. Do not place in hot water or near radiators, stoves, or other sources of heat. Do not puncture or incinerate container, or store at temperatures over 50°C. Do not use on animals or humans. Cover fish bowls and remove pets for one hour when spraying. In homes or dwellings, remove or cover all exposed foods and cooking utensils before spraying. Avoid contact with skin, eyes and clothing. Avoid inhalation of spray. Wash after using. Keep from freezing.

**FIRST AID:** If in eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to mouth, if possible. Call a poison control centre or doctor for further treatment advice. If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. If swallowed, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person. Take container label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: This product contains petroleum distillates. Vomiting may cause aspiration pneumonia. Treat symptomatically.

DISPOSAL: When container is empty, press button to release all pressure. Do not throw into fire. Wrap and dispose in household garbage.
