Dithane M-45 Seed Protectant Fungicide is a non-mercurial seed protectant for treatment of barley, oats, wheat, flax and corn.

Drill Box Treatment

- Step #1: Layer the bottom 1/3 of the drill box with seed already treated with Dithane M-45 Seed Protectant Fungicide.
- Step #2: Put an equal amount of untreated seed on top of this and cover with a sufficient amount of Dithane M-45 Seed Protectant Fungicide to achieve the desired dosage. Thoroughly mix this together with a stick or some similar instrument. Caution: Do not use bare hands!
- Step #3: Repeat this procedure for the final 1/3rd portion of seed.
- Step #4: Repeat steps #2 and 3 when the drill box is 2/3rd empty.

Slurry Treatment (Not to be used with flax)

Dithane M-45 Seed Protectant Fungicide can be used as a slurry treatment with Panogen and Mist-O-Matic machines. Concentrations and equipment should be adjusted to provide the rates mentioned earlier. Care should be taken to provide thorough mixing prior to and as close to use as possible.

RESISTANCE MANAGEMENT RECOMMENDATIONS

For resistance management, please note that Dithane M-45 Seed Protectant Fungicide contains a Group M fungicide. Any fungal population may contain individuals naturally resistant to Dithane M-45 Seed Protectant Fungicide and other Group M fungicides. A gradual or total loss of pest control may occur over time if these fungicides are used repeatedly in the same fields. Other resistance mechanisms that are not linked to site of action but specific for individual chemicals, such as enhanced metabolism, may also exist. Appropriate resistance-management strategies should be followed.

To delay fungicide resistance:

- Where possible, rotate the use of Dithane M-45 Seed Protectant Fungicide or other Group M fungicides with different groups that control the same pathogens.
- Use tank mixtures with fungicides from a different group when such use is permitted.
- Fungicide use should be based on an IPM program that includes scouting, historical information related to pesticide use and crop rotation and considers cultural, biological and other chemical control practices.
- Monitor treated fungal populations for resistance development.
- If disease continues to progress after treatment with this product, do not increase the use rate. Discontinue use of this product, and switch to another fungicide with a different target site of action, if available.
- Contact your local extension specialist or certified crop advisors for any additional pesticide resistance-management and/or IPM recommendations for specific crops and pathogens.
