DIRECTIONS FOR USE:

Overexposure to 2,4-D may cause coughing, burning, dizziness or temporary loss of muscle coordination. Other possible effects of overexposure include fatigue, muscle weakness

or nausea. Treat symptomatically. Gastric lavage may be indicated. Alkaline diuresis may be beneficial in severe cases.
