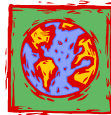

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN

Do not allow product to contact food, feedstuffs or water. May cause skin or eye irritation. Avoid contact with eyes, skin or clothing. Use water-proof gloves to handle product and wash hands thoroughly with soap and water after handling. FIRST AID:

IF SWALLOWED: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

ENVIRONMENTAL PRECAUTIONS:

This product is potentially pathogenic to honey bees. Avoid applying to areas where honey bees are actively foraging or around hives. **DO NOT** apply directly to aquatic habitats (such as lakes, rivers, sloughs, ponds, coulees, prairie potholes, creeks, marshes, streams, reservoirs, ditches and wetlands), estuaries or marine habitats.

DO NOT allow effluent or runoff containing this product to enter lakes, streams, ponds or other waters.

DIRECTIONS FOR USE:

For suppression of darkling beetles in poultry facilities. Do not use a fungicide prior to application of this product.

Apply balEnce™ Biological Beetle Bait under feed lines and feed pans at a rate of 8.9 to 17.8 grams per square meter using a drop spreader or hand shaker to a maximum of 10.88 kg (24 lbs) of bait per house. Application should be made prior to bird placement. Re-treatment maybe necessary if beetle numbers are high at the start of a flock and should be done in 4 week intervals.

STORAGE: Keep in original container. Store in a cool, dry place at a room temperature not exceeding 27°C and out of direct sunlight. Do not store for longer than 4 years from the date of manufacture.

DISPOSAL:

1. Triple- or pressure-rinse the empty container. Add the rinsings to the spray mixture in the tank.
2. Follow provincial instruction for any required additional cleaning of the container prior to its disposal.
3. Make the empty container unsuitable for further use.
4. Dispose of the container in accordance with provincial requirements.
5. For information on disposal of unused, unwanted product, contact the manufacturer or the provincial regulatory agency. Contact the manufacturer and the provincial regulatory agency in case of spill and for clean-up of spills.
