Repeat applications and thorough coverage of target foliage are required to maintain disease protection.

#### **DIRECTIONS FOR USE:**

Avoid application of this product when winds are gusty.

Use a small backpack or hand held sprayer to apply **AEF 11-05.** Dilute 3.6 mL (3/4 teaspoon) of **AEF 11-05** in 400 mL to 1L of c lean water and apply ov er 4 square metres of foliage. The final s pray volume must be sufficient to ensure thorough coverage of the target foliage but not to the point of excessive run-off Agitate to maintain s uspension. Avoid application when significant rainfall is imminent. Subsequent applications may be made every 7-14 days if symptoms persist.

The pre-harvest interval (PHI) is 0 (zero) day.

#### STORAGE:

Store in the original container, at temperatures between 4° C and 25° C. Storage at cooler temperatures is preferred. Store container upright and keep tightly closed when not in use. After extended storage, shake or stir contents to assure a uniform suspension. The product should be used within 12 months of the date of manufacture. To prevent contamination, store this product away from food or feed.
