DIRECTIONS FOR USE:

DO NOT apply to surfaces that may come into contact with food/feed. Cover or remove all food/feed. Cover all food/feed processing surfaces, equipment and utensils or thoroughly wash following treatment. **DO NOT** administer by mouth. Shake bottle well before using. Wet dog or cat thoroughly with warm water. Apply shampoo and rub shampoo into coat beginning at the head and working backward until entire body is covered (approximately 5 mL/kg). Pay special attention to neck, hindquarters, areas under legs, around the tail and between toes. **DO NOT** apply to dog or cat's face, eyes, nose, mouth or genitals of **dog or cat**. Rinse the dog or cat thoroughly with water to remove all traces of shampoo. Avoid contact with dog or cat's mouth, face, eyes and genitals For difficult infestations, allow the lather to remain for 3 - 5 minutes. Rinse thoroughly to remove all traces of shampoo on the dog or cat's coat. **DO NOT** use on dog or catsunder 8 weeks of age. **DO NOT** treat nursing females. **DO NOT** use on sick animals. **DO NOT** use on animals under drug or pesticide treatment. Treatment must be repeated only if the pest problem reoccurs.

Ticks are difficult to control, therefore take care to treat ticks individually. For effective flea and tick control, treatment of the **dog or cat** should be combined with sanitation of any area used by the dog or cat. Vacuum floors, carpets and furniture (discard vacuum bag a fter use) and wash the dog or cat's bedding, living quarters and surrounding areas. If pest problems persist, a premise treatment with an insecticide labelled for that use may be required. A veterinarian should be consulted when flea infestation continues to be a problem on the dog or cat.

USE LIMITATIONS:

DO NOT allow dog or cat to lick the suds from the coat or to ingest any of the shampoo.

DO NOT use this shampoo more often than once every 2 weeks.

PRECAUTIONS:

HUMANS: KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed or a bsorbed through skin. May irritate eyes. Avoid contact with mouth, eyes, skin and clothing.
