Remains effective in the control of [ants] [cockroaches] [earwigs] [fleas] [silverfish] [crickets] [millipedes] [centipedes] for as long as TERRO® ANT KILLING POWDER is present.

DIRECTIONS: Shake well. Open top cap. Holding bottle at 45-degree angle, powder should flow freely when squeezed.

INDOOR USE: [EARWIGS] [ANTS] [COCKROACHES] [SILVERFISH] [CRICKETS] [MILLIPEDES] [CENTIPEDES]. Lightly coat at a rate of 50 grams per 10 m² the areas where [ants] [cockroaches] [earwigs] [silverfish] [crickets] [millipedes] [centipedes] [these pests] are found or may hide such as cracks and crevices, behind and beneath stoves, refrigerators, sinks, cabinets, garbage cans, around pipes and drains, window frames and in attics and basements. Hit pests directly where possible. Repeat treatment as necessary.

[FLEAS: Thoroughly dust sleeping quarters of pets and surrounding cracks, crevices, carpeting and baseboards. Repeat treatment as necessary.]

OUTDOOR USE: [EARWIGS] [ANTS] [CRICKETS] [MILLIPEDES] [CENTIPEDES]. Lightly coat the area where these pests are found and may hide including ant hills and trails, around foundations, window frames, door sills, patios, garages, sheds, outside entrance ways and cracks and crevices. Repeat treatment as necessary.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Avoid breathing dust. Do not use as a space spray. Avoid contact with eyes. Not for direct food contact.

FIRST AID: If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. **If inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. **If swallowed:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

DISPOSAL: Do not re-use empty container. Wrap and dispose of empty container with household garbage.
