TORRENT 400SC Agricultural Fungicide can be used in dilute sprays. Thorough, uniform coverage is essential for disease control.

NOTE: Slowly invert container several times to assure uniform mixture.

Dosage rates on this label indicate litres of **TORRENT 400SC** Agricultural Fungicide per hectare. Apply **TORRENT 400SC** Agricultural Fungicide in sufficient water volume to obtain coverage of the foliage. Spray volume to be used will vary with the amount of plant growth and will range from 200 to 600 litres per hectare unless specified otherwise. For all foliar applications, **TORRENT 400SC** should be tank-mixed with a non-ionic or

organosilicone surfactant (such as Sylgard OFX-0309) at the manufacturer's label recommendations.

The required amount of **TORRENT 400SC Agricultural Fungicide** should be added slowly into the spray tank during filling. Keep agitator running when filling spray tank and during spray operations.

DO NOT apply using fogging or ultra low volume equipment. **DO NOT** apply using handheld mistblowers or handheld airblast equipment.

TANK MIXING AND COMPATIBILITY

This product may be tank mixed with a fertilizer, a supplement, or with registered pest control products, whose labels also allow tank mixing, provided the entirety of both labels, including Directions For Use, Precautions, Restrictions, Environmental Precautions, and Spray Buffer Zones are followed for each product. In cases where these requirements differ between the tank mix partner labels, the most restrictive label must be followed. Do not tank mix products containing the same active ingredient unless specifically listed on this label.

TORRENT 400SC is generally compatible with other fungicides, insecticides, fertilizers and micronutrient products provided sufficient free water is available for dispersion of all the tank mix products. However, the physical compatibility of this product with tank mix partners must be evaluated before use. Conduct a jar test with intended tank-mix product(s) prior to preparation of large volumes. DIRECTION FOR USE: AERIAL APPLICATION - CUCURBITS ONLY

Apply only by fixed-wing or rotary aircraft equipment which has been functionally and operationally calibrated for the atmospheric conditions of the area and the application rates and conditions of this label.

Label rates, conditions and precautions are product specific. Read and understand the entire label before opening this product. Apply only at the rate recommended for aerial application on this label. Where no rate for aerial application appears for the specific use, this product cannot be applied by any type of aerial equipment.

Although TORRENT 400SC Agricultural Fungicide has limited systemic activity, it should be treated as a protectant fungicide and applied before the disease enters the crop. TORRENT 400SC Agricultural Fungicide is recommended for use as part of an Integrated Pest Management (IPM) program, which may include the use of disease resistant crop varieties, cultural practices, crop rotation, biological disease control agents, pest scouting and disease forecasting systems aimed at preventing economic pest damage. Practices known to reduce disease development should be followed. Consult your provincial/territorial agricultural authorities for additional IPM strategies established in your area. TORRENT 400SC Agricultural Fungicide may be used in disease forecasting programs that recommend application timing based upon environmental factors that favour disease development.

Resistance Management

For resistance management, please note that **TORRENT 400SC Agricultural Fungicide** contains a Group 21 fungicide. Any fungal population may contain individuals naturally resistant to **TORRENT 400SC Agricultural Fungicide** and other Group 21 fungicides. A gradual or total loss of pest control may occur over time if these fungicides are used repeatedly in the same fields. Other resistance mechanisms that are not linked to site of action, but specific for individual chemicals, such as enhanced metabolism, may also exist. Appropriate resistance-management strategies should be followed.

To delay fungicide resistance:

- DO NOT make sequential applications of TORRENT 400SC Agricultural Fungicide or other fungicides in the same group. After one application, alternate TORRENT 400SC Agricultural Fungicide with at least one application of fungicide having a different mode of action that controls the same pathogens.
- Do not exceed the total number of applications of **TORRENT 400SC Agricultural Fungicide** per season per crop as stated in the "Directions for use" section of the label.
- Use tank mixtures with fungicides from a different group that is effective on the target pathogen when such use is permitted.

For these uses, ISK Biosciences Corporation has not fully assessed performance (efficacy) and/or crop tolerance (phytotoxicity) under all environmental conditions or for all crop varieties when used in accordance with the label. The user should test the product on a small area first, under local conditions and using standard practices, to confirm the product is suitable for widespread application.

Greenhouse and Outdoor Ornamental Plants:

Because of the large diversity of plants in the Ornamentals groups, it is not possible to test TORRENT 400SC Agricultural Fungicide on every ornamental species and varieties covered under the following claims. To ensure that TORRENT 400SC Agricultural Fungicide is compatible with an ornamental plant variety under specific conditions, it is recommended that small scale tests be performed to assess any possible phytotoxicity or other unintended side effects before making large scale applications.

Container Grown Plants - Soil Application

For control of root and crown rot diseases of ornamentals, including conifers, grown in containers in greenhouses, outdoor nurseries and landscapes apply **TORRENT 400SC Agricultural Fungicide** as a soil drench or soil surface spray. Do not make more than 2 soil applications of **TORRENT 400SC Agricultural Fungicide** per crop cycle. **TORRENT 400SC Agricultural Fungicide** may also be applied via drip irrigation systems. For drench applications to containerized plants, use enough of the specified water solution to wet the root zone with minimal run-through (see Maximum Drench Volume table below).

Field Grown (Bed) Plants – Soil Application

For control of root and crown rot in field-grown (bed) plants, including forest tree nurseries, with drench applications, use sufficient water solution to allow for penetration into the root zone. For soil surface applications made in outdoor nurseries, irrigate with at least ½ inch (1.27cm) of water if rainfall does not occur within 24 hours. For all field grown (bed) plant applications, apply **TORRENT 400SC Agricultural Fungicide** only to the root zone area of the plant at the rate of 234 - 468mL of **TORRENT 400SC Agricultural Fungicide** per 1000 liters. Do not exceed 9350L of this mixture per hectare per application (1748g a.i./ha). Do not make more than 2 applications of **TORRENT 400SC Agricultural Fungicide** per year to field grown (bed) plants (3496g a.i./ha/yr.). Applications may also be applied via drip irrigation.

Container and Field Grown (Bed) Plants - Foliar Application

Applications of **TORRENT 400SC Agricultural Fungicide** should begin when conditions are favorable for disease development or when plants first exhibit disease symptoms, from germination to mature crop. For foliar applications against foliar blights, apply sufficient spray solution to thoroughly wet the foliage to the point of run-off (do not exceed 1000 liters per hectare).

Do not exceed 3 applications of **TORRENT 400SC Agricultural Fungicide** per crop cycle for control of downy mildews or Phytophthora foliar diseases.

Greenhouse Cut flowers

For greenhouse grown cut flowers, do not make more than 2 applications of **TORRENT 400SC Agricultural Fungicide**. Do not exceed a rate of 273 mL/1000L of water for foliar applications.

Spray Buffer Zones

Use of the following spray methods or equipment **DO NOT** require a spray buffer zone: handheld or backpack sprayer and spot treatment.

The spray buffer zones specified in the table below are required between the point of direct application and the closest downwind edge of sensitive terrestrial habitats (such as grasslands, forested areas, shelter belts, woodlots, hedgerows, riparian areas and shrublands), sensitive freshwater habitats (such as lakes, rivers, sloughs, ponds, prairie potholes, creeks, marshes, streams, reservoirs and wetlands) and estuarine/marine habitats.
