ANIMAL HOUSING (such as poultry and livestock housing)

**ANTS:** Apply to cracks and crevices around doors and windows and other places where ants may be found. For best results, locate and treat nests within structures. Where ants are trailing inside, apply as a crack and crevice treatment to active areas such a s baseboards, corners, around pipes, in and b ehind cabinets, behind and under refrigerators, sinks, fur naces and stoves. When combining baits and crack and crevice insecticides, apply insecticides in cracks and crevices along baseboards and infested surfaces. Use baits in other areas that are untreated by residual insecticides.

**COCKROACHES, CRICKETS and FIREBRATS:** Apply as a coarse, low pressure spray t o cracks and crevices where these pests hide, such as b aseboards, corners, storage areas, closets, around water pipes, doors and windows, attics and eaves, cabinets, behind and under refrigerators, sinks, furnaces, and stoves, the underside of shelves, drawers and similar areas.

**CENTIPEDES, MILLIPEDES AND SOWBUGS**: Apply around doors and windows where these pests may be found or where they may enter premises. Treat baseboards, storage areas, and other locations. Apply barrier treatments to prevent infestation as described below. (See **BARRIER TREATMENT**).

**BED BUGS:** Crevices, baseboards, loose plaster, behind bed frames and headb oards, and beneath beds and furniture. Do not apply to furniture surfaces or mattre sses where people will be laying or sitting. Infe sted bedding should not be treated, but should be removed , placed in sealed plastic bags, and taken for laundering and drying at high temperatures.

**Application Within Food Handling Establishments:** (places other than private residences in which exposed food is held, processed, prepared, or served) including, but not limited to, areas for receiving, storage, packing (canning, bottling, wrapping, boxing), preparing fo ods, edible waste storage and enclosed processing systems (mills, dairies, edible oils, syrups) and serving areas. Use as a crack and crevice treatment in and around both food and non-food areas. Apply in small amounts directly into cracks and crevices, using equipment capable of delivering

a pin-stream spray, in points between different elements of construction, between equipment and floor, openings leading to voids and hollow spaces in walls, equipment and bases. Food contact surfaces and equipment should be cleaned with an effective cleaning compound and rinsed with potable water before using.

Take extreme care that the product is not intro duced into the air. Avoid contamination of food and food processing surfaces.

**Application Within Food Serving Areas:** (facilities where foods are served, such as dining rooms): Apply as a crack and crevice treatment. Avoid tre ating areas likely to be contacted by food. (Do not apply when facility is in operation or foods are exposed.) Food must be covered or removed in area be ing treated. Do not a pply directly to food or allow applications to contaminate food.

To facilitate application, remove debris and leaf litter from next to the foundation, cut back vegetation and branches that touch t he foundation, and move or rake back rocks, deep mulch, or other potential pest harborage next to the foundation. Apply the b and up to 3.0 m wide around the structure and upwards along the foundation to 0.9 m and around windows, doors, and roof overhangs. A pply as a coarse spray to thorough ly and uniformly wet th e foundation and/or band area so that the insecti cide will reach the soil or thatch level where pests may be active.

**NOTE:** Do not use water base sprays of MasterLine LambdaCy Insecticide in conduits, motor housings, junction boxes, switch boxes, or other electrical equipment because of possible shock hazard. For best results, thoroughly wash out sprayer and screen with water and detergent before using MasterLine LambdaCy Insecticid e. MasterLine LambdaCy Insecticide has not stained or caused damage to painted or varnished surface s, plastics, fabrics or other surfaces where water applied alone causes no damage.

# **Mixing Instructions**

MasterLine LambdaCy Insecticide is intended for dilution with water for application using hand held or po wer operated application equipment as a coarse spray for crack and crevice treatments. Application equipment that deliver s low volu me treatments, such as the Micro-Injector or Actisol applicator, may also be used to make crack and crevice treatments. Fill applicator tank with the desired volume of water and add MasterLine LambdaCy Insecticid e.

Close and shake before use in order to ensure proper mixing. Shake or re-agitate applicator tank before use if application is interrupted. Mix only amount of treatment volume as required.

#### **Resistance-Management Recommendations**

For resistance management, please note that MasterLine LambdaCy Insecticide contains a Group 3 insecticide. A ny insect p opulation may contain individuals naturally resistant to MasterLine LambdaCy Insecticide and other Group 3 insecticides. The resistant individuals may dominate the insect population if this group of insecticide is used repea tedly in the same fields. Other resistance mechanisms that are not lin ked to site of action, but specific f or individual chemicals, such as enhanced metabolism, may also exist. Appropriate resistance-management strategies should be followed.

#### To delay insecticide resistance:

Where possible, rotate the use of MasterLine LambdaCy Insecticide or other Group 3 insecticides with different groups that control the same pests in a field.

Use tank mixtures with insecticides from a different group when such use is permitted.

Insecticide use should be based on an IPM program that includes scouting, record keeping, and considers cultural, biological and other chemical control practices.

Monitor treated pest populations for resistance development.

Contact your local extension specialist or certified crop a dvisors for any additional pesticid e resistance-management and/or IPM recommendations for the specific site and pest problems in your area.
