**PRECAUTIONS**  
**PREVENT ACCESS BY UNAUTHORIZED PERSONNEL**

**Danger – eye irritant.** Avoid contact with eyes. Workers should wash hands before eating, drinking, chewing gum, using tobacco or the toilet.

**PHYSICAL OR CHEMICAL HAZARDS**

**FIRST AID**

**Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.**

**If swallowed:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

**If inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

**If in eyes:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

**TOXICOLOGICAL INFORMATION**

No specific antidote. Employ supportive care. Treatment should be based on judgment of the physician in response to reactions of the patient.

**AGRICULTURAL CHEMICAL**

Do not ship or store with food, feeds, drugs or clothing.

**ENVIRONMENTAL HAZARDS**

Do not contaminate any body of water by direct application, cleaning of equipment or disposal of wastes. **TOXIC** to non-target terrestrial plants. **TOXIC** to aquatic organisms.

**STORAGE**

STORE ABOVE 0°C (32°F) TO KEEP FROM CRYSTALIZING. Crystals will settle to the bottom. If allowed to crystallize, warm to 20°C (68°F) and mix well or recirculate to redissolve before using. Keep in original container during storage. Store in a cool, dry, well ventilated place away from seed, feed, fertilizers or other pesticides. Do not contaminate water, food or feed by storage or disposal. Keep away from fire or open flame, or other source of heat.

**DISPOSAL AND DECONTAMINATION**

Canadian manufacturers should dispose of unwanted active ingredients and containers in accordance with municipal or provincial regulations. For additional details and clean up of spills, contact the manufacturer or the provincial regulatory agency.

To be used only in the manufacture of a herbicide which is registered under the *Pest Control Products Act*.
