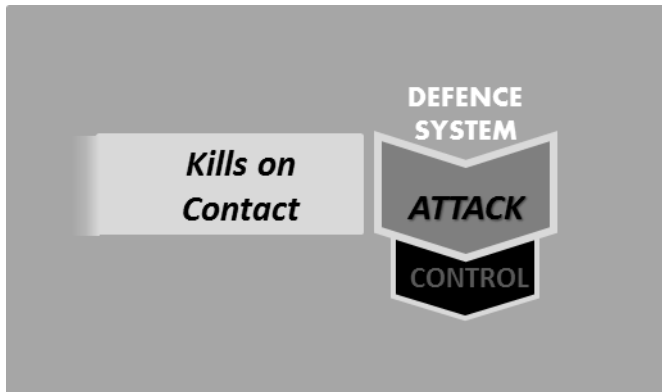

It also keeps on killing ants, cockroaches, earwigs, spiders and crickets with long-lasting action after you spray, for up to 10 days.

**PRECAUTIONS:** KEEP OUT OF REACH OF CHILDREN. May irritate skin. Avoid contact with skin. Wash hands after use. Do not use on humans, pets or foodstuffs. Remove or cover exposed food and drinking water before application. Remove or cover dishes, utensils, food processing equipment and food preparation surfaces, or wash them before use. Remove pets, birds and cover fish aquariums before spraying. Bystanders must NOT be present during the application of this product. Do not allow adults, children or pets to enter the treated area until sprays have dried.

CONTENTS UNDER PRESSURE. Do not place container in hot water or near radiators, stoves or other sources of heat. Do not puncture or incinerate container or store at temperatures over 50°C. Keep away from open flame or spark.

**FIRST AID: If swallowed:** Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give **any** liquid to the person. Do not give anything by mouth to an unconscious person. **If on skin or clothing:** Take off contaminated clothing. Rinse skin

immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. **If inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. **If in eye:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

#### **TOXICOLOGICAL INFORMATION:**

This product contains petroleum distillates. Vomiting may cause aspiration pneumonia.

#### **DISPOSAL:**

#### **DIRECTIONS FOR USE:**

Kills ants, cockroaches, earwigs, spiders, multi-coloured Asian ladybird beetles, centipedes, silverfish and crickets.

SHAKE WELL BEFORE EACH USE. Hold container upright. Do not spray up into the air. Point spray opening toward area to be sprayed and press button firmly. Hold about 30 cm from area being sprayed. Spray until surfaces are wet. Avoid excessive wetting of asphalt, tile, rubber and plastic materials as staining may occur. It is recommended to check for potential staining and damage by spraying a small, inconspicuous area and examining the treated area after it has dried before treating an entire area.

Spray inside house as a spot treatment directly to pests or to areas where the listed pests may enter or hide, such as door sills, baseboards, window frames, cracks and

crevices in and walls, surfaces around pipes, behind and beneath cabinets, refrigerators, sinks, stoves etc. Retreat every 10 days if pests continue to be a problem.

Apply **ONLY** as a spot treatment.

**Spot treatment:** Spot application is localized to a surface area not more than 0.2m<sup>2</sup>.

Spots are not to be adjoining. The combined area of spots is not to exceed 10% of the total surface area of a room.

**DO NOT** apply as a broadcast treatment.

**DO NOT** apply as a space spray.

**DO NOT** apply as an indoor perimeter treatment.

**DO NOT** apply any product containing cyfluthrin more than once every 10 days.

**DO NOT** apply to surfaces that may come into contact with food/feed. Ventilate treated areas after application by opening windows and doors. Use fans where required to aid in the circulation of air. If you experience respiratory effects (such as cough, sore throat, or shortness of breath), nausea, dizziness, or eye irritation upon re-entering areas treated with any product containing cyfluthrin, ventilate the area more and vacate the premises. If you continue to experience effects after additional ventilation, contact your health care professional.

**DO NOT** allow adults, children or pets to enter the treated area until sprays have dried.
