DIRECTIONS FOR USE

For use only in the manufacture and formulation of products registered under the *Pest Control Products Act*.

PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN AND PREVENT ACCESS BY UNAUTHORIZED PERSONNEL

May cause moderate eye irritation. Harmful if inhaled or absorbed through skin. Avoid contact with eyes, skin, or clothing or inhaling dust or spray mist. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse. This pesticide is toxic to fish. Do not contaminate water when disposing of equipment washwaters.

FIRST AID

If swallowed

Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If on skin or clothing

Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled

Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If in eyes

Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION

WARNING SYMPTOMS: May cause irritation of nose, throat, eyes and skin. Treat as above for skin contact. Treat symptomatically.

STORAGE AND DISPOSAL

Mancozeb Technical Fungicide has limited storage life. This product should be used within 30 days of manufacture.

Storage: Store in the original container in a dry area. If allowed to become wet the product will deteriorate and represent a fire hazard. Keep away from sources of ignition (e.g. sparks and open flame). Close bag when not in use. Do not store in a manner where cross-contamination with other pesticides, fertilizers, food or feed could occur. If spilled during storage or handling sweep up spillage and dispose of in accordance with the disposal instructions listed below.

Decontamination and Disposal: Canadian manufacturers should dispose of unwanted active ingredients and containers in accordance with municipal or provincial regulations. For additional details on cleanup of spills, contact the provincial regulatory agency.
