ENVIRONMENTAL PRECAUTIONS

Toxic to aquatic organisms. Toxic to bees. Avoid application around blooming plants. DIRECTIONS FOR USE

SHAKE WELL BEFORE USING. Can hold can upright while spraying, but has an all angle 360 degree spray action.

FOR USE ON INDOOR ORNAMENTAL HOUSEPLANTS

To kill Aphids, Spotted mites, Thrips, Adult whiteflies **on the following houseplants:** African violet, Aralia, Christmas cherry, Chrysanthemums, Cineraria, Dieffenbachia, Fuchsia, Gloxinia, Ivy, Lantana, Neathe bella palm, Petunia, Rose, Snapdragon: **DO NOT** apply to houseplants grown for food or feed (e.g., Herbs). **DO NOT** use on greenhouse plants. When listed pests first appear, spray to thoroughly cover all foliage, including upper and lower leaf surfaces until damp. **DO NOT** wet plants to the point of runoff or drip. When spraying, hold can 30-45 cm from plants to avoid wetting the foliage. To enhance effectiveness of this product, apply directly to the listed pests where possible. **DO NOT** exceed 3.7 g per m² (2.8 seconds/m²). Treatment must only be repeated after 7 days if pest problem persists or reoccurs. Use with caution on new growth and on tender young plants and foliage. Test on one or two leaves to determine safety.

FOR OUTDOOR USE ON PEAR TREES, TOMATOES, BEANS, GRAPEVINES AND OUTDOOR ORNAMENTAL PLANTS

Use Limitations

- **DO NOT** apply to any body of water.
- **DO NOT** contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.
- Avoid application of this product when winds are gusty.

To kill Thrips, Leafhoppers, Spotted mites, Lace bugs, Aphids, Adult Whiteflies, Climbing cutworms, Japanese beetles, Flea beetles, Armyworms **on pear trees, tomatoes, beans, grapevines and the following ornamental plants:** Asters, Azaleas, Begonias, Carnations, Camellias, Chrysanthemums, Dahlias, Delphiniums, Geraniums, Gladiolas, Irises, Marigolds, Petunias, Roses, and Snapdragons, Evergreens, Small deciduous trees, Shrubs and Vines. When listed pests first appear, spray to thoroughly cover all foliage, including upper and lower leaf surfaces until damp. **DO NOT** wet plants to the point of runoff or drip. When spraying, hold can 30-45 cm from plants to avoid wetting the foliage. To enhance effectiveness of this product, apply directly to the listed pests where possible. **DO NOT** exceed 3.7 g per m² (2.8 seconds/m²). Treatment must only be repeated after 7 days if pest problem persists or reoccurs. Apply in early morning or evening – not in direct sunlight. Spray only when air is still and temperature is below 32°C. Use with caution on new growth and on tender young plants and foliage. Test on one or two leaves to determine safety.

STORAGE

Store this product away from food or feed.
