NOTICE TO USER

This pest control product is to be used only in accordance with the directions on the label. It is an offence under the *Pest Control Products Act* to use this product in a way that is inconsistent with the directions on the label.

FIRST AID:

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

IF SWALLOWED: Call a poison control centre or doctor immediately for treatment advice.

Do not induce vomiting unless told to do so by a poison control centre or doctor. **DO NOT** give any liquid to the person. **DO NOT** give anything by mouth to an unconscious person.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15–20 minutes.

TOXICOLOGICAL INFORMATION:

This product contains petroleum distillate. Skin exposure may cause transient sensations (tingling, burning, itching, numbness). Other symptoms of exposure could include respiratory effects (such as cough, respiratory irritation, or shortness of breath), nausea, headache or dizziness. Vomiting may cause aspiration pneumonia. Treat symptomatically.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Contents under pressure. **DO NOT** place in hot water or near radiators, stove or other sources of heat, or store at temperatures over 50°C. **DO NOT** spray near open flame or spark or while smoking. Harmful if swallowed, inhaled or absorbed through skin. May cause skin and/or eye irritation. Avoid contact with eyes, skin, or clothing. **DO NOT** use this product in or on electrical equipment due to possibility of shock hazard. **DO NOT USE IN ANIMAL FEED AREAS.** **DO NOT** use in bulk food storage areas. **DO NOT** use in cupboards where food or cooking utensils are stored.

ENVIRONMENTAL PRECAUTIONS

Toxic to aquatic organisms. Toxic to bees. Avoid application around blooming plants. If applications must be made during the blooming period, restrict applications to be evening when most bees are not foraging. Toxic to beneficial arthropods (which may include predatory and parasitic insects, spiders, and mites). Minimize exposure to non-target areas.

DIRECTIONS FOR USE:

For use indoors as a crack and crevice treatment to control ants, spiders, sowbugs, earwigs, cockroaches, crickets, millipedes, silverfish, fleas, carpet beetles and brown dog ticks. K-G Quick Breaking Crawling Insecticide Foam I – AF 2014 can also be used outdoors to control ants in cracks and crevices.

SHAKE WELL BEFORE USING. Gently insert the (wand or applicator wand or extension tube, applicator hose or jet tube) into the spray nozzle before using. This product is designed for

applying into cracks and crevices that are difficult to reach. The foaming action of this formula completely fills tight crevices leaving an insecticidal active residue.

Within the specified use location, to enhance effectiveness of this product, apply directly to the listed pests where possible. When applied indoors, good sanitary practices should be maintained to prevent re-infestation.

Application to vinyl and aluminum siding (particularly lightly colored, aged, weathered or otherwise damaged) may result in staining, bleaching or discoloration. Factors such as extreme heat and direct sunlight can promote damage. Always pre-test a small inconspicuous area to be treated, for colour fastness and staining. Pre-test siding. Evaluate 30 minutes after test application for potential staining. Never apply to vinyl or aluminum siding while exposed to direct sunlight or during the heat of day. Do not apply to tapestries, wall paper or similar materials that may stain.

Use Limitations for all uses:

- **DO NOT** apply when people or pets are present.
- **DO NOT** allow people or pets to enter treated areas until sprays have dried.
- **DO NOT** use in areas where food is processed, handled, served or stored.
- **DO NOT** apply to surfaces that may come into contact with food/feed. Cover or remove all food/feed. Cover all food/feed processing surfaces, equipment and utensils or thoroughly wash them following treatment. Any food/feed accidentally contaminated with spray solution must be discarded.
- **DO NOT** apply to overhead areas or in confined spaces (e.g. indoors in attics, crawlspaces, small storage rooms, closets; and outdoors to eaves, soffits)
- **DO NOT** allow spray to drip onto non-target surfaces.
- When applied indoors: Ventilate treated areas after application by opening windows and doors or using fans where required to aid in the circulation of air.
- When applied outdoors: **DO NOT** apply in areas where plants are grown for food or feed (e.g. vegetables, fruit, herbs). **DO NOT** apply to any body of water. **DO NOT** contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes. Avoid application of this product when winds are gusty.
- When applied outdoors to the exterior of surfaces of buildings and on listed structures: **DO NOT** treat soil, turf or other plants adjacent to the treatment site.

FOR INDOOR USE AT BUILDINGS

How to Apply

DO NOT APPLY AS A SPACE SPRAY, PERIMETER OR BROADCAST TREATMENT.
Apply as an indoor crack and crevice treatment only. Crack and crevice is an application directly into narrow openings on the surface of the structure. It does not include the treatment of exposed surfaces. Narrow openings typically occur at expansion joints, utility entry points and along baseboards and mouldings.

INDOOR USE:

To Control Ants, Carpet beetles, Cockroaches, Crickets, Earwigs, Millipedes, Sowbugs, Spiders, Silverfish.

Thoroughly treat indoor building surfaces in hard to reach areas including cracks, crevices in walls, floors and ceilings; along and behind baseboards; around water pipes and tanks; walls behind and floors beneath appliances (e.g. refrigerators and stoves) and furniture (e.g., drawers, cabinets and storage units); around sinks, drains and pipes; around interior foundations; around garbage containers; localized areas of floors and floor coverings; and points of entry (e.g. around windows and doors). **DO NOT** exceed 9 seconds per m². Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

To Control Brown Dog Ticks and Fleas:

DO NOT apply to pet bedding, furniture, mattresses, linens, toys or clothing. Apply to indoor building surfaces, including cracks and crevices in walls and floors, along and behind baseboards, window and door frames; and localized areas of floor and floor coverings. **DO NOT** exceed 9 seconds per m². Treatment must only be repeated after 7 days if pest problem persists or reoccurs. **DO NOT SPRAY PETS WITH THIS PRODUCT.** Only treat pets with products specifically registered for use on that type of pet. For effective flea and tick control indoors, clean any area used by the pet. Cleaning the areas includes vacuuming floors, carpets, furniture, etc. (discard vacuum bag after use) and washing the pet's bedding, living quarters, and surrounding area.

FOR OUTDOOR USE ON ANT HILLS:

To control ants: Directly spray ant hills and trails. **DO NOT** exceed 9 seconds per m². Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

STORAGE:

Store this product away from food or feed.

DISPOSAL:

- **DO NOT** puncture or incinerate
- When container is empty, press the valve to release all remaining pressure.
- **DO NOT** reuse the empty containers. Dispose of empty container in household garbage. Unused or partially used products should be disposed at provincially or municipally designated hazardous waste disposal sites.
