DIRECTIONS FOR USE:

To be used only in the manufacture of a pesticide which is registered under the *PEST CONTROL PRODUCTS ACT*.

PRECAUTIONS:

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.

Avoid contact with eyes, skin and clothing. Fatal if swallowed. May cause eye or skin irritation. Do not inhale vapours. Wash well immediately after handling and before eating, drinking and smoking. FIRST AID:

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:

A special antidote does not exist. Treat symptomatically.

STORAGE:

1. Store in cool, dry, ventilated area, away from seeds, fertilizers, insecticides, fungicides, herbicides or other biocides.
2. Keep away from heat, fire and sparks.
3. Store in tightly closed original container. Do not store below 0°C.
