DIRECTIONS FOR USE:

Clearaid SCP is used to control the growth of algae in swimming pools, spas, hot tubs and decorative fountains. Clearaid SCP should never be added to potable water systems.

SWIMMING POOLS, SPAS, HOT TUBS AND DECORATIVE FOUNTAINS **DO NOT use in decorative fountains with fish.**

For maximum effectiveness of Clearaid SCP in swimming pools with heavy growth of algae, clean pools prior to using Clearaid SCP. For pools having just visible algae growth, add an initial dose of 75 to 125 mL of Clearaid SCP per 10,000 L of water and remove settled algae debris 24 hours later by cleaning, brushing and vacuuming the pool and backwashing the filter. For treatment of a freshly cleaned and filled pools, add initially 50 to 75 mL of Clearaid SCP per

10,000 L of water. To maintain pools free of visible algae growth, subsequent additions of 15 to 30 mL of Clearaid SCP per 10,000 L of water should be made every 5-7 days after the initial treatment.

Uniform distribution of Clearaid SCP throughout the water in the pool is necessary for maximum effectiveness. Clearaid SCP is compatible with those chemicals normally used to treat pools and is effective at both acid and alkaline pH. Clearaid SCP can be used in pools treated with chlorine chemicals and may reduce the amount of those chemicals normally required. However, do not mix Clearaid SCP with concentrated dry or liquid chlorine products.

PRECAUTIONS

DANGER. KEEP OUT OF REACH OF CHILDREN

Do not mix with any other chemical. Harmful if swallowed. Avoid contact with skin, eyes, clothing and contamination of food. Wear chemical safety goggles, chemical-resistant gloves, a long-sleeved shirt and long pants during handling, clean-up and repair activities. In addition, a chemical-resistant apron is required for workers handling end-use products in industrial settings. Wash thoroughly after handling. Immediately remove contaminated clothing and wash before reuse.

FIRST AID

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for further treatment advice. **IF SWALLOWED**: Call poison control center or doctor immediately for treatment advice. Have person sip a glass of water, if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person. **IF INHALED**: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration Preferably by mouth-to-mouth if possible. Call a poison control center or doctor for further treatment advice.

STORAGE AND DISPOSAL

STORAGE:
