## **PRECAUTIONS**

Direct contact causes moderate eye irritation. Potential skin sensitizer. Causes skin irritation. Inhalation causes respiratory tract and mucous membrane irritation. Avoid breathing dust. **DO NOT** get in eyes. Avoid contact with skin or clothing.

Product is not intended for use on animals.  
Do not contaminate water, food, or foodstuffs.

When loading and applying this product, and during clean-up/maintenance activities, workers must wear a long-sleeved shirt and pants, water-proof gloves, goggles, a dust mask, shoes, and socks. During prolonged exposure to dust, use of a NIOSH approved respirator is recommended.

Do not apply in a way that this product will contact workers or other persons, either directly or through drift.

Do not apply in areas accessible to children and pets.

Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet. Remove and wash contaminated clothing before reuse.

Apply only when the potential for drift to areas of human habitation or areas of human activity such as houses, cottages, schools, and recreational areas is minimal. Take into consideration wind speed, wind direction, temperature inversion, application equipment, and sprayer settings.

## **FIRST AID**

**If swallowed:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

**If inhaled:** Move affected person(s) to fresh air. If person is not breathing, call 911 or an ambulance then give artificial respiration, preferably by mouth-mouth, if possible. Remove contact lenses if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

**DIRECTIONS FOR USE**

Read entire label prior to use and use product as directed.

Kills Ants, Bed Bugs, Cockroaches, Crickets, Fleas (including larvae), Spiders (excluding Black widow, Brown Recluse)\*, Silverfish and Wasps on contact.

\*Some species of spiders may be less susceptible to TyraTech TechDust.

Use in and around commercial, industrial, institutional and residential structures such as hotels, hospitals, multi-family housing, schools, nursing homes, offices, restaurants, kitchens, laboratories, factories, slaughter-houses, production facilities, modes of transport (not to include airplane cockpits), garages, storage units and other areas of human habitation or activity.

Pests must be treated directly with TyraTech TechDust to be killed. For both indoor and outdoor uses, apply TyraTech TechDust® uniformly to the treatment area as needed. Do not exceed the rates listed in the table below. .Re-apply as needed if pests continue to be a problem or if dust becomes wet. . Store sealed product in a dry area between uses.

<b>Pest</b>	<b>Maximum Application Rate (grams / m<sup>2</sup>)</b>
Cockroaches	40 to 140
Wasps	60
Ants Crickets	40
Bed Bugs	20
Fleas Silverfish Spiders	10

\*Use the higher rate for large species of cockroach (e.g., American cockroach) and the lower rate for small species of cockroach (e.g., German cockroach).

Not intended for use on animals.

Do not apply to plants or surrounding soil.

Applications should be made so that direct contact with bodies of water (to include aquariums or ornamental ponds), or contact resulting from run-off does not occur.

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes

**FOR INDOOR USE:** Apply Tyratech TechDust® as a crack and crevice, spot or wall void treatment to kill listed pests. For best results, apply dust directly to the pest. May be applied to areas where insects are hiding or harboring such as behind backsplashes, baseboards, under tack strips, edges of linoleum or carpet, under appliances, counters, window ledges, behind and under furniture, garages, attics, bathrooms, basements and crawl spaces. **Prior to use, test a small inconspicuous area to check for possible damage such as staining or discolouration.** Ventilate room after treatment.

**Food Areas and Food Handling:** Apply product directly into tunnels and voids in areas away from food or food preparation areas such as walls, floorboards, under and around appliances, waste disposal areas and any other area where insects may be hiding or harboring. Prior to product application, cover or remove food items. Avoid direct contact with food or food preparation areas.

**FOR OUTDOOR USE:** To kill listed pests that enter structures from outdoor areas, apply along edges of patios, cracks or expansion joints in or along foundations or pavement, driveways, porches, doorways (to include French and sliding glass doors), window sills and weep holes. Dust may also be applied in those areas where pests harbor around the structure including under doormats, under and around potted plants, in the cracks and crevices, columns, eaves and soffits. ..

**STORAGE** Store at temperatures between 0° C and 25° C. Store container upright and keep tightly closed when not in use.

**DISPOSAL**

Do not reuse empty container. Thoroughly empty the contents of the container into the application device. Make the empty container unsuitable for further use. Dispose of the container in accordance with provincial requirements. For information on the disposal of the unused, unwanted product and the cleanup of spills, contact the provincial regulatory agency or the manufacturer.
