PRECAUTIONS:**PREVENT ACCESS BY UNAUTHORIZED PERSONNEL**

Avoid breathing spray mist.

Avoid contact with skin, eyes and clothing.

DO NOT discharge effluent containing this product into sewer systems, lakes, streams, ponds, estuaries, oceans or other waters.

DO NOT APPLY BY AIR

When handling the concentrate, wear a long sleeve shirt and long pants, chemical-resistant gloves and eye protection. Wash the outside of the gloves before removing. Wash splashes from skin and eyes IMMEDIATELY with plenty of water. While spraying, wear a long sleeve shirt and long pants. Wear chemical-resistant gloves if contact with spray nozzles is necessary. Avoid working in spray mist. Avoid all drift or contact with other vegetation. After spraying, wash hands and shower thoroughly with soap and water. While using product, do not eat, drink or smoke. Wash hands and exposed skin with soap and water thoroughly before eating, drinking, smoking, applying cosmetics or using the toilet. Keep product away from food, drink and animal feed.

Store product in original container, tightly closed and in a safe place.

DO NOT use or store product near heat or open flame. DO NOT apply beyond the field boundary.

FIRST AID:**IF SWALLOWED:**

Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

IF ON SKIN OR CLOTHING:

Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

IF INHALED:

Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

IF IN EYES:

Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.
