DIRECTIONS FOR USE:

1. Remove Bait Traps from Plastic Frame.
2. Remove all sources of food such as crumbs, sugar, and grease spots.
3. Place under sinks–refrigerator–cupboard.
4. Place by ant trails where ants are numerous.
5. For Garden & Lawn: Place along trails & ant colonies. Put traps 3-6 meters apart.

In 3-7 days ants will be killed. Replace with new traps every 30 days. Avoid contamination of feed and foodstuff.

STORAGE AND DISPOSAL:

STORAGE: Store in original container away from food and feedstuffs. Keep product in a locked storage area inaccessible to children and pets.

DISPOSAL: Do not reuse empty container. Securely wrap in newspaper and discard in household garbage.
