Doktor Doom Sleep Tight Fabrics and Upholstery Professional Strength Bed Bug Killer provides quick knockdown and kill with two highly effective non-residual insecticides. Occasionally adult fleas may be present in treated areas when reintroduced from infested animals or if newly emerged from pre-existing flea larvae or pupae.

Doktor Doom Sleep Tight Fabrics and Upholstery Professional Strength Bed Bug Killer leaves no bad smell or sticky mess and, used as directed, does not stain furnishings.

Controls the following insects on contact: Ants, Bedbugs, Black Carpet Beetles (adults), Crickets, Fleas (adults), Sowbugs, Spiders and Brown Dog Ticks.

FOR USE IN: Apartments, Automobiles, Boats, Campers, Homes, Pet Sleeping Areas, Recreation Vehicles and Storage Areas. Do not use in food handling, storage or preparation areas while food is present. DO NOT apply as a broadcast application. ONLY perimeter/spot or crack and crevice is permitted. Perimeter/spot application is defined as an application in a wide band or strip around the perimeter of the room or over a small area (< 2 ft2/0.2 m2). Crack and crevice applications are defined as an application with the use of a pin stream nozzle, into cracks and crevices in which pests hide or through which they may enter a building. Application to upholstered furniture must be limited to tufts and seams or spot treatment.

FOR USE INDOORS: Shake can well before use. Direct spray nozzle so that spray contacts insects and other arthropods directly.

CRACK AND CREVICE TREATMENT: Hold can 15 cm (6") from infested surfaces. Apply at a rate of approximately one linear metre per 5 seconds.

SPOT TREATMENT: Hold can approximately 60 to 90 cm (2-3') from infested surfaces. Apply in one-second bursts. Avoid wetting upholstered furniture and draperies. If used on light or delicate upholstery fabrics, draperies, or carpet, test in an inconspicuous place before use. Contact with spray is sufficient to kill insects. Since this product is to be used as a contact spray for the control of listed pests, the coverage of the can will be variable. Based upon laboratory data, the contents of the can will cover from 3.4 square meters for ants to 14.6 square meters for fleas and brown dog ticks. If using as a spot treatment on upholstered furniture or carpet/rugs, do not repeat more often than once every two weeks.

ANTS, BEDBUGS, CRICKETS, SOWBUGS AND SPIDERS: Spot treat for pests if they are found on rugs, carpets, or furniture. Cracks and crevices should be treated along baseboards, shelves, in closets, cupboards, and areas where these pests are seen. If used on light or delicate upholstery fabrics or carpet, test in an inconspicuous place before use. For bedbugs, it may be advisable to take bed apart and treat cracks, joints, and interior or framework where bedbugs are seen, or are suspected to be hiding (provided there is reason to believe that a bedbug infestation exists). DO NOT treat bed linens. DO NOT use articles until treatment is dry.

ADULT FLEAS AND BROWN DOG TICKS: Using one second bursts, spray fleas and brown dog ticks when seen on carpets, rugs, upholstered furniture and any other surfaces avoiding feed and foodstuff contamination. Treat under and around furniture if pets frequently rest in these areas. When treating upholstered furniture, lift cushions and treat under cushions and in crevices of furniture where fleas or ticks may hide. Do not apply this product to pets.

ADULT BLACK CARPET BEETLES (Dermestids): Directly spray as many insects as possible, being careful to avoid spraying exposed surfaces of carpets, drapes and upholstered furniture. When spraying upholstered furniture, spray under cushions and the underside of furniture if possible. Area rugs should be treated on the bottom side only. Allow treatments to dry before putting rug back in place. Treat cracks and crevices of shelves and closets, areas under furniture, cracks and crevices of baseboards only in areas where these insects are seen or suspected.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. KEEP CHILDREN AND ANIMALS OFF TREATED SURFACES. Harmful if swallowed or absorbed through skin. Contains petroleum distillate.
