DIRECTIONS FOR USE:

To be used only in the manufacture or formulating of a pesticide which is registered under the PEST CONTROL PRODUCTS ACT.

PRECAUTIONS:

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Strictly observe all precautions for handling and using pesticides. Fatal if swallowed. Do not ingest. May be harmful if inhaled. Do not breathe dust. May irritate eyes. Avoid contact with skin, eyes and clothing. Do not use or store near heat or open flame.

Wear protective clothing including, coveralls/apron, chemical resistant gloves, mask/face shield, goggles and boots when handling, mixing or loading this product. Use in well-ventilated area. Wash thoroughly with soap and water after handling product and before eating, drinking, or smoking. Wash contaminated clothing with soap and water and separate from other laundry before reuse. This product is toxic to fish and wildlife. Keep out of lakes, streams or ponds. Do not contaminate water by the cleaning of equipment or disposal of wastes.

FIRST AID TREATMENT:

- IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.
- IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.
- IF SWALLOWED: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.
- IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

TOXICOLOGICAL INFORMATION:

STORAGE:

Store upright in the original, tightly sealed container in a well ventilated room. Store in a cool, dry place away from food, feed or other pesticides. Keep out of reach of unauthorized persons. Protect from sun and humidity. Do not store near heat or open flame.
