**DIRECTIONS FOR USE:** This high concentrate pump spray repels mosquitoes, black flies, stable flies, biting midges, deer flies, ticks and chiggers. Not greasy. Won't stain. Hold container upright, apply sparingly, not under clothing and only when necessary, reapply after 6 hours if necessary.

**TO APPLY TO FACE:** Spray hands and apply avoiding eyes and mouth. Wash hands, after application. Do not spray in enclosed spaces.

**PRECAUTIONS:** KEEP OUT OF THE REACH OF CHILDREN. Do not use on children under 12 years of age. Avoid contact with eyes and mouth, cuts, wounds, sunburned skin, rayon, Dynel and acetate, plants, furniture finishes, plastics and painted surfaces. Keep away from open flame or sparks.

**FIRST AID:** If in eyes: hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If swallowed: call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If inhaled: move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If irritation or other adverse effects develop wash with soap and water immediately. Seek medical attention if symptoms persist. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:** Treat symptomatically.

**DISPOSAL:** Do not reuse container. When container is empty, discard in household garbage.
