(905) 792-6571 DIRECTIONS FOR USE:

Kills Dog and Cat Fleas, American Dog & Brown Dog Ticks: Shake well before using. Ticks are difficult to control and must be sprayed directly. Pay special attention to the neck, hindquarters, areas under legs, around the tail and between toes. DO NOT apply to the Dog's / Cat's face, eyes, nose, mouth or genitals. DO NOT use this spray more often than once every 2 weeks. Treatment must only be repeated if pest problem persists or reoccurs.

FOR USE ONLY ON DOGS AND CATS OVER 12 WEEKS OLD

USE LIMITATIONS

DO NOT use on puppies or kittens less than 12 weeks old. DO NOT use on dogs or puppies weighing less than 0.2268 kg. DO NOT use on cats or kittens weighing less than 1.5 kg.

DO NOT USE ON ANY OTHER ANIMAL.

Consult veterinarian before using on pregnant, sick, aged or nursing animals or animals under drug or other pesticide treatment.

Use ONLY in a well-ventilated area, preferably outdoors.

DO NOT use solely as a shampoo when there is no pest problem.

HOW TO APPLY

TO CONTROL dog and cat fleas, American dog ticks and Brown Dog ticks.: Wet the dog's / cat's head with water to drive the pests onto the body. Hold the can in an upright position from a distance of about 25 - 30 cm above the back and spray the entire body of the dog / cat, beginning at the head and working towards the tail. As you spray, use hands to fluff the fur of the dog / cat so that the spray will penetrate to the skin. Only spray until the fur is damp – not wet. Wipe off excess product from the dog / cat with a dry cloth and then comb or brush. Bathing of the dog / cat may affect product efficacy. DO NOT exceed 6.0 g – 7.6 g / animal (3 seconds – 4 seconds / animal).

For effective flea and tick control, treatment of the pet should be combined with sanitation of any area used by the pet. Vacuum floors, carpets and furniture (discard vacuum bag after use) and wash the pet's bedding, living quarters and surrounding areas. If pest problems persist, an insecticidal treatment of the premises may be required. A veterinarian should be consulted when flea infestation continues to be a problem on the pet.

PRECAUTIONS:

HUMANS: KEEP OUT OF REACH OF CHILDREN. Avoid breathing spray mist. Avoid contact with skin, eyes and clothing. Harmful if swallowed, inhaled or absorbed through skin. Not for use on humans. Avoid contact with pet until dry. After handling or applying, wash hands (or any other skin that came into contact with the product) with soap and water. Avoid contact with food, food utensils or places where food is prepared or stored. Discontinue use if dermal or nasal irritations develop. In homes or dwellings, remove or cover all exposed foods and cooking utensils before spraying. Toxic to birds. Toxic to fish and other aquatic life. Cover fish aquaria in vicinity of treatment area. Wash contaminated clothing before reuse. Keep from freezing. **CONTENTS UNDER PRESSURE.** DO NOT place in hot water or near radiators, stoves or other sources of heat. DO NOT puncture or incinerate can or store at temperatures over 50°C. **PETS:** Harmful if swallowed or inhaled. May irritate eyes, nose and throat. Avoid direct spray of pet's mouth, face,

SIDE EFFECTS: Monitor your DOG after application. Side effects may include skin irritation such as redness or scratching; changes in behaviour such as agitation or lethargy; gastrointestinal effects such as vomiting or loss of appetite. If these or other side effects occur consult your veterinarian or registrant at 905-792-6571.

Monitor your CAT after application. Side effects may include skin irritation such as scratching or hair loss at the application site; changes in behaviour such as agitation or lethargy; gastrointestinal effects such as drooling, vomiting or loss of appetite. If these or other side effects occur consult your veterinarian or registrant at 905-792-6571.

STORAGE: Store away from feed and food.

FIRST AID: If in eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. If swallowed, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. **PETS:** Sensitivities may occur after using ANY pesticide for pets. If signs of sensitivity occur, bathe the pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical or veterinary attention.
