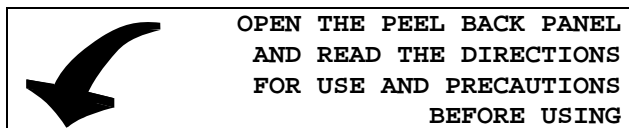

## **CONTROLS OVER 50 VARIETIES OF LAWN WEEDS**

**CONTROLS:** Dandelions, Plantains, Chickweed, Clover, Bedstraw, Black Medick, English Daisy, Curled Dock, Heal-all, Ground Ivy (Creeping Charlie), Knotweed, Ragweed, Shepherd's-Purse, plus over 35 other lawn weeds.

### **DIRECTIONS:**

Turn nozzle to desired position - FOAM or STREAM. FOAM marks treated weeds, allowing you to easily see where you've sprayed. STREAM provides coarse spray that does not foam. Squeeze trigger to operate. **STORAGE:** Rotate nozzle to closed position. Store product in original container in a safe place. Keep from freezing.

- This product is only effective when applied to the leaves of actively growing weeds. This product will not prevent new weeds - apply only when weeds are present.
- DO NOT water within 24 hours after application. Rain within 6 hours reduces effectiveness.
- Spray acts within a few days and weeds gradually die. Grass fills in as weeds disappear.
- Some weeds may require up to 4 weeks for complete kill. Repeat in 3-4 weeks if necessary.
- This product is designed to target treatment of weedy areas of lawns.
- DO NOT apply to any body of water.
- DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.
- DO NOT directly spray or allow the spray to drift onto ornamentals, flowers, shrubs, vegetable and fruit crops, or exposed tree roots, as this product may injure these desirable broadleaf terrestrial plants.
- This product may injure bentgrass.
- Avoid application of this product when winds are gusty.
- DO NOT apply to driveways, sidewalks or any other hard surface.

### **PRECAUTIONS:**

**KEEP OUT OF REACH OF CHILDREN.** Wash hands after use. Do not store near seeds, fertilizers, insecticides or fungicides. Keep from freezing.

**Protective Clothing:**

- Applicators must wear long-sleeved shirt, long pants, socks, shoes and chemical-resistant gloves.

**Operator Use Precautions:**

- Wash hands before eating, drinking, using tobacco or using the toilet.
- After treating, wash thoroughly.
- If pesticide penetrates clothing, remove immediately; then wash contaminated skin thoroughly and shower. Launder contaminated clothing separately before reuse.

**Re-entry Interval:**

- Do not allow people (other than applicator) or pets on treatment area during application. Do not enter treated areas until spray has thoroughly dried.
