**DIRECTIONS FOR USE:**

To be used only in the manufacture, formulation, or repackaging of a pesticide which is registered under the *PEST CONTROL PRODUCTS ACT*.

**PRECAUTIONS**

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Harmful or fatal if swallowed. May irritate eyes. Avoid contact with eyes, skin, and clothing. Wear long sleeved shirt and long pants, chemical resistant gloves, goggles, face shield, or safety glasses, and chemical resistant apron and boots when handling this product. Wash thoroughly with soap and water after handling and before eating, drinking, smoking and using the toilet. Remove contaminated clothing and wash before reuse. **FIRST AID**

**If in eyes:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

**If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

**If swallowed:** Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to by a poison control center or doctor. Do not give anything by mouth to an unconscious person.

**If inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth to mouth, if possible. Call a poison control center or doctor for further treatment advice.
