PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse.

PERSONAL PROTECTIVE EQUIPMENT (PPE):

Workers must wear a long-sleeved shirt, long pants, chemical resistant gloves and goggles or a face shield during mixing, loading, clean-up and repair. In addition, dust filtering respirator protection is required during handling if there is a potential for dust generation.

Follow manufacturer's instructions for cleaning/maintaining personal protective equipment. If no such instructions exist for washables, use detergent and hot water. Keep and wash personal protective equipment separately from other laundry.

USER SAFETY RECOMMENDATIONS:

Users should wash hands before eating, drinking, chewing gum, using tobacco, or using the toilet. Users should remove clothing immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing. Users should remove personal protective equipment immediately after handling this product. Wash the outside of gloves before removing. Wash thoroughly as soon as possible.

FIRST AID:

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice,

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

This product is toxic to fish. Do not contaminate bodies of water or surrounding area through direct disposal, cleaning of equipment or runoff water. Open dumping is prohibited. Do not discharge effluent containing this product into lakes, streams, ponds, rivers, estuaries, oceans or public waters.

DIRECTIONS FOR USE:

Do not apply this product in a way that will contact workers or other persons.

Suggested application levels are based on laboratory and field evaluations and are typical for the use areas indicated. Suggested use levels are reported as percentage weight/weight in the final use product.

Household Cleaning Products

including all-purpose cleaners, dishwashing liquids,
car polishes, tire shines, stain removers and wet wipes 0.1-1.0%

Detergents and Soft Soaps

including laundry detergents and fabric softeners 0.1-1.0%

Do not contaminate water, food or feed by storage and disposal.

STORAGE:

Troyguard IP06 should not be stored at temperatures below 32°F (0°C). Drums should be stored in an upright position with all bungs tightly closed.

DISPOSAL:

1. Triple or pressure-rinse the empty container. Add the rinsings to the treatment site.
2. Follow provincial instructions for any required additional cleaning of the container prior to its disposal or reconditioning.
3. Make the empty container unsuitable for further use.
4. Dispose of the container in accordance with provincial requirements.
5. For information on the disposal of unused, unwanted product, contact the manufacturer or the Provincial Regulatory Agency. Contact the manufacturer and the provincial regulatory agency in case of a spill, and for clean-up of spills.
